A BILL FOR AN ACT

RELATING TO BUSINESS MANAGERS FOR THE DEPARTMENT OF EDUCATION.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that school, complex, and
- 2 complex area administrators are responsible for wide-ranging
- 3 financial assignments, which detract the focus from the
- 4 curriculum and instruction endeavors of the school, the
- 5 promotion of student achievement, and the continuous improvement
- 6 within the complex area. These student-achievement centered
- 7 initiatives are even more critical with the required academic
- 8 rigor of the No Child Left Behind Act and with the continued
- 9 implementation of the department of education strategic plan.
- 10 The legislature further finds that the weighted student
- 11 formula represents a method of allocating budgets to schools,
- 12 based on student needs and school characteristics so available
- 13 resources are better targeted to support student achievement.
- 14 The weighted student formula also provides school principals
- 15 with increased control and flexibility over their school budgets
- 16 to implement initiatives to improve student achievement.

1	The	legislature believes that the increased mandates and
2	responsib	ilities on school, complex, and complex area
3	administr	ators requires the assistance of highly knowledgeable
4	and quali	fied individuals with business backgrounds to allow
5	schools t	o efficiently and effectively manage the operational
6	and finan	cial aspects of the school, complex, or complex area.
7	The	purposes of business manager positions within the
8	departmen	t of education are to:
9	(1)	Provide direct business and financial management
10		assistance and oversight to principals and complex
11		area superintendents in the areas of school-based
12		budgeting;
13	(2)	Develop weighted student formula financial plans;
14	(3)	Conduct financial reporting and monitoring;
15	(4)	Conduct budget versus actual variance analysis;
16	(5)	Prepare and present financial recommendations to the
17		school and complex area administrators;
18	(6)	Oversee facilities management, including repair and
19		maintenance and capital improvement projects;
20	(7)	Understand and provide guidance on procurement
21		transactions and laws;

There is appropriated out of the general 10 revenues of the State of Hawaii the sum of \$, or so 11 much thereof as may be necessary for fiscal year 2007-2008, and 12 the same sum, or so much thereof as may be necessary for fiscal 13 year 2008-2009, to hire one full-time business manager for each 14 department of education school complex area to provide financial 15 and operational advice and counsel to school, complex, and 16 complex area administrators and support staff. 17 The sums appropriated shall be expended by the department of education for the purposes of this Act. 18 19 SECTION 4. Statutory material to be repealed is bracketed

and stricken. New statutory material is underscored.
