A BILL FOR AN ACT

RELATING TO CORRECTIONS.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. Approximately twelve Hawaii residents are
- 2 housed in various prisons in the continental United States under
- 3 the Interstate Corrections Compact. The current monitoring of
- 4 conditions at these prisons or of the health and safety of the
- 5 Hawaii inmates held in those prisons has proven to be
- 6 insufficient. The purpose of this Act is to require the
- 7 mainland branch of the corrections division of the department of
- 8 public safety to improve its monitoring and reporting on the
- 9 conditions of Hawaii residents held in mainland prisons under
- 10 the Interstate Corrections Compact by collecting standard
- 11 quarterly reports from each of these facilities on each Hawaii
- 12 resident inmate it houses.
- 13 SECTION 2. Section 355D-5, Hawaii Revised Statutes, is
- 14 amended to read as follows:
- 15 "[4] §355D-5[4] Contracts[4] and reporting. (a) The
- 16 director of public safety may enter into such contracts on
- 17 behalf of the State as may be appropriate to implement the

- 1 participation of the State in the Interstate Corrections Compact
- 2 pursuant to article III thereof. No such contract shall be of
- 3 any force or effect until approved by the governor and
- 4 comptroller.
- 5 (b) The mainland branch of the corrections division of the
- 6 department of public safety shall submit standardized, quarterly
- reports on each Hawaii resident inmate incarcerated in 7
- 8 facilities pursuant to the Interstate Corrections Compact
- 9 containing the following information:
- 10 (1) Status of the incarcerated person's health;
- 11 (2) Any behavioral or disciplinary issues;
- (3) Progress in rehabilitative programs; and 12
- 13 (4) Any complaints filed by the incarcerated person and
- 14 how such complaints have been resolved.
- 15 The reports shall be due on October 5, 2007, and on the 5th of
- 16 each December, April, July, and October thereafter. The reports
- shall cover the three months immediately prior to that date. 17
- 18 The reports shall comply with and be available for public
- 19 inspection pursuant to chapter 92F, provided that the
- 20 information in these reports is to be minimally redacted to
- 21 exclude the incarcerated persons name and other sensitive and
- 22 protected information."
