A BILL FOR AN ACT

RELATING TO A BIOENERGY MASTER PLAN.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF HAWAII:

- 1 SECTION 1. The legislature finds that significant steps
- 2 were taken during the 2006 legislative session to move Hawaii
- 3 towards a more sustainable energy future: renewable energy tax
- 4 credits were increased and made permanent, programs for
- 5 renewable hydrogen and solar water heating were established, and
- 6 energy efficiency measures are now required to be considered by
- 7 state agencies. A biofuel preference for state agencies was
- 8 also established as well as a mandate requiring twenty per cent
- 9 of highway fuels be comprised of alternate fuels by the year
- **10** 2020.
- 11 The legislature also finds that Hawaii should further
- 12 diversify its energy system and reduce its dependence on
- 13 imported petroleum by introducing bioenergy resources into the
- 14 overall energy system.
- In response to this desire to diversify Hawaii's energy
- 16 system, a biofuels summit and a bioenergy workshop were held
- 17 during 2006 to explore the potential for a domestic bioenergy

- 1 and biofuels future. Both resulted in the realization that
- 2 initiating a bioenergy industry in Hawaii must first address a
- 3 diverse and very complex set of issues that involves many public
- 4 and private stakeholders.
- 5 The purpose of this Act is to create a bioenergy master
- 6 plan task force that is charged with developing a bioenergy
- 7 master plan for Hawaii. This master plan will set the course
- 8 for the coordination and implementation of policies and
- 9 procedures to develop a bioenergy industry in Hawaii.
- 10 SECTION 2. (a) There is established in the department of
- 11 business, economic development, and tourism, a temporary
- 12 bioenergy master plan task force. The department shall be
- 13 responsible for administering the work of the temporary task
- 14 force, providing a facilitator, and submitting reports to the
- 15 legislature. The goal of the temporary task force shall be to
- 16 develop a bioenergy master plan for the State that addresses:
- 17 (1) Specific objectives, milestones, and timelines;
- 18 (2) Water resources;
- 19 (3) Land resources;
- 20 (4) Distribution infrastructure for both marine and land;
- 21 (5) Labor resources and issues;

11	(b)	The members of the temporary task force shall include					
12	the follo	wing:					
13	(1)	The director of business economic development, and					
14		tourism, or the director's designee;					
15	(2)	The chair of the board of agriculture, or the chair's					
16		designee;					
17	(3)	The chair of the board of land and natural resources,					
18		or the chair's designee;					
19	(4)	The director of labor and industrial relations, or the					
20		director's designee;					
21	(5)	The director of health, or the director's designee:					

1	(6)	The dean of the college of tropical agriculture and
2		human resources at the University of Hawaii, or the
3		dean's designee;
4	(7)	The director of the Hawaii natural energy institute,
5		or the director's designee;
6	(8)	The chair of the public utilities commission, or the
7		chair's designee;
8	(9)	The state consumer advocate, or the consumer
9		advocate's designee;
10	(10)	The chair of the Hawaii energy policy forum, or the
11		chair's designee;
12	(11)	A representative from the United States Department of
13		Energy;
14	(12)	A representative from the United States Department of
15		Agriculture;
16	(13)	A representative from the petroleum industry;
17	(14)	A representative from each of the State's electric
18		utilities;
19	(15)	A representative from the Hawai'i Agricultural
20		Research Center; and
21	(16)	A representative from the Hawai'i Farm Bureau
22		Federation

1	(c)	The	bioenergy	master	plan	task	force	may	form
2	workgroups	and	subcommit	ttees to	o:				

- (1) Obtain input from stakeholders, bioenergy
 professionals, and any other individuals as may be
 determined necessary by the task force; and
- 6 (2) Perform any other functions as may be deemed necessary
 7 by the task force for the fulfillment of their
 8 functions.
- 9 (d) Members of the bioenergy master plan task force shall
 10 serve without compensation but shall be reimbursed for expenses,
 11 including travel expenses, necessary for the performance of
 12 their duties.
- 13 (e) The bioenergy master plan task force shall be exempt
 14 from chapter 92, Hawaii Revised Statutes; provided that the task
 15 force shall make a good faith effort to make its proceedings and
 16 work products accessible and available to the general public in
 17 a manner consistent with the intent of chapter 92, Hawaii
 18 Revised Statutes.
- 19 (f) The bioenergy master plan task force shall be exempt
 20 from the requirements of chapter 103D, Hawaii Revised Statutes.
- 21 (g) The bioenergy master plan task force shall submit an
 22 interim report of its findings and recommendations, including

- 1 any proposed legislation, to the legislature no later than
- 2 twenty days prior to the convening of the regular session of
- 3 2008. The bioenergy master plan task force shall submit a final
- 4 report of its findings and recommendations, including a final
- 5 bioenergy master plan, as well as any proposed legislation, to
- 6 the legislature no later than twenty days prior to the convening
- 7 of the regular session of 2009.
- 8 SECTION 3. There is appropriated out of the general
- 9 revenues of the State of Hawaii the sum of \$200,000, or so much
- 10 thereof as may be necessary for fiscal year 2007-2008, and the
- 11 same sum, or so much thereof as may be necessary for fiscal year
- 12 2008-2009 to support the operations of the bioenergy master plan
- 13 task force.
- 14 The sums appropriated shall be expended by the department
- 15 of business, economic development, and tourism for the purposes
- 16 of this Act.
- 17 SECTION 4. This Act shall take effect on July 1, 2007.
