SENATE CONCURRENT RESOLUTION

REQUESTING THE CONVENING OF A TASK FORCE TO ADDRESS THE ISSUE OF SHARING CRIMINAL BACKGROUND INFORMATION BETWEEN THE FEDERAL AND STATE GOVERNMENT.

WHEREAS, immigration law is a creation of federal law, 1 2 encompassing many areas, including employment, citizenship, and 3 benefits; and 4 WHEREAS, since the September 11th, 2001 bombing of the World 5 Trade Center, the federal government has increased their 6 7 emphasis on securing our borders through initiatives like the 8 creation of the Department of Homeland Security; and 9 10 WHEREAS, one of the tools the Department of Homeland Security uses in an effort to secure our borders is background 11 checks, although the current mechanisms for these checks are 12 backlogged; and 13 14 WHEREAS, the Department of Homeland Security is improving 15 the sharing of information amongst federal departments and with 16 the states, the agency itself is predominantly a counter-17 18 terrorism organization; and 19 WHEREAS, events over the past several years, including, 20 most recently, the murder of Karen Etrell, highlight a different 21 kind of border security problem, that of immigrants with 22 23 criminal backgrounds entering the country and this state, and committing crimes; and 24 25 WHEREAS, the Department of Homeland Security does deny 26 visas to known international gang members because of their ties 27 to international terrorism; and 28 29 WHEREAS, although our federal and state constitutions 30 31 guarantee the freedom to associate, and by inference, to travel freely within the country, those legal guarantees and our 32

1 separate state governments make it difficult to identify and track immigrants with criminal backgrounds; and 2 3 4 WHEREAS, improved information sharing between the federal 5 government and the states could help address this public safety issues without infringing on the constitutional freedoms that 6 7 guarantee our freedom to associate and travel; now, therefore, 8 9 BE IT RESOLVED by the House of Representatives of the 10 Twenty-fourth Legislature of the State of Hawaii, Regular Session of 2008, the Senate concurring, that the legislature 11 requests the convening of a task force to identify the legal and 12 logistical impediments to the sharing of criminal background 13 information of immigrants between the federal government and the 14 15 state and between state departments; and 16 BE IT FURTHER RESOLVED that the task force should be 17 composed of: 18 19 20 (1)The United States Attorney for Hawaii, or his designee; 21 22 23 (2)The Attorney General, or his designee; 24 25 (3) The police chiefs of each county, or their designees; 26 27 (4) The Superintendent of Education, or her designee 28 The director of Human Services, or her designee 29 (5) 30 31 (6) The director of Health, or her designee; and 32 33 BE IT FURTHER RESOLVED the task force submit their recommendations, including proposed legislation, to the 34 legislature no later than twenty days prior to the convening of 35 the 2009 Regular Session; and 36 37 38 BE IT FURTHER RESOLVED that certified copies of this Concurrent Resolution be transmitted to the United States 39 Attorney for Hawaii, the attorney general, the police chiefs of 40 each county, the Superintendent of Education, the director of 41 Human Services, and the director of Health. 42 43
