## SENATE CONCURRENT RESOLUTION

## REQUESTING THE DEPARTMENT OF HEALTH TO CONDUCT A STUDY OF ADULT RESIDENTIAL CARE HOMES.

WHEREAS, an adult residential care home is defined under 1 2 section 321-15.1, Hawaii Revised Statutes, as any facility that provides twenty-four hour living accommodations, for a fee, to 3 adults unrelated to the family, who require at least minimal 4 assistance with the activities of daily living, personal care 5 services, protection, and health care services, but who do not 6 7 need the professional health services provided in an intermediate, skilled nursing, or acute care facility; and 8 9 WHEREAS, in recent years, there has been a proliferation of 10 the establishment of adult residential care homes on Oahu; and 11 12 WHEREAS, this proliferation of the establishment of adult 13 residential care homes may have unintended consequences, 14 15 particularly with regard to land use and zoning; and 16 17 WHEREAS, many of the adult residential care homes are located in residential neighborhoods characterized by single 18 family residences, and in commercial or mixed use areas; and 19 20 WHEREAS, concentrations of the adult residential care homes 21 22 in these areas have attendant traffic, parking, delivery, noise, 23 trash collection, and emergency services response challenges; and 24 25 WHEREAS, a neighborhood composed largely of adult 26 residential care homes could adversely affect individuals with 27 disabilities and would be inconsistent with integrating persons 28 with disabilities into the community; and 29 30 31 WHEREAS, the Department of Health is authorized to license the establishment and operation of adult residential care homes; 32 33 and

1 WHEREAS, the Department of Health's authority is apparently 2 superior to that of the City and County of Honolulu's Department 3 of Planning and Permitting to regulate these facilities, 4 including the regulation of the locations of the facilities, 5 their distance from each other, and whether they are compatible 6 with the land use; and 7 8 WHEREAS, there is apparently no regulation to provide an 9 opportunity for public notice, review, or comment, especially by 10 adjoining property owners, regarding pending applications to 11 establish, modify, or expand adult residential care homes; and 12 13 WHEREAS, while the City and County of Honolulu has revised 14 15 each of the development plans and sustainable community plans for Oahu in recent years, the Department of Health has not 16 conducted a similar review or revision of its rules regarding 17 18 adult residential care homes; and 19 WHEREAS, the Department of Health should conduct a study of 20 residential care home facilities; now, therefore, 21 22 BE IT RESOLVED by the Senate of the Twenty-fourth 23 Legislature of the State of Hawaii, Regular Session of 2008, the 24 House of Representatives concurring, that the Department of 25 Health is requested to conduct a study of residential care home 26 facilities; and 27 28 29 BE IT FURTHER RESOLVED that in completing the study, the Department of Health is requested to: 30 31 Examine and determine the adequacy of the statutes, 32 (1)administrative rules, and inspection and enforcement 33 processes, related to the establishment, modification, 34 and expansion of adult residential care facilities; 35 36 (2) Determine whether adequate opportunity exists for 37 public notice and participation in the inspection and 38 enforcement processes related to the establishment, 39 modification, and expansion of adult residential care 40 facilities: 41 42 Determine whether the licensing and regulation of (3) 43 44 adult residential care facilities has adversely SCR SMO 08-005.doc
