SENATE CONCURRENT RESOLUTION

URGING THE DEPARTMENT OF EDUCATION TO ENSURE RECOGNITION OF CERTAIN RIGHTS OF PARENTS OF CHILDREN WHO HAVE BEEN REFERRED FOR SPECIAL EDUCATION SERVICES.

WHEREAS, the parents of children who are referred for 1 special education services are faced with heavy emotional and 2 physical challenges every day; and 3 4 WHEREAS, the Department of Education (DOE) should make 5 conscientious efforts to assist these parents with the 6 educational needs of their children; and 7 8 WHEREAS, DOE should recognize that as the individuals who 9 probably most understand a child's social, emotional, and 10 physical needs, parents should be allowed to have input in the 11 most appropriate education for their child; and 12 13 WHEREAS, despite the progress made by DOE in improving the 14 educational services provided to children with special needs, 15 many parents still feel frustrated that they are, more often 16 than not, left out of decisions made about their child's 17 education and unable to navigate DOE's special education system 18 to do what they believe is in their child's best interests; and 19 20 WHEREAS, these parents are entitled to certain rights, and 21 DOE should do due diligence to assist these parents by informing 22 them of their rights; and 23 24 WHEREAS, DOE already recognizes the rights granted by 25 federal law to students with disabilities and their parents or 26 guardians, the intent of which is to provide an equal 27 educational opportunity to all students with disabilities, and 28 these rights are described in a publication entitled, "Rights of 29

30 Parents and Students in Identification, Evaluation and31 Educational Placement of Students with Disabilities and the

(Section 504, Subpart D, Chapter 53, the Rehabilitation Act of 1 1973); and 2 3 WHEREAS, the Georgia Department of Education regularly 4 updates and publicizes a document entitled, "Your Rights As 5 Parents - Regarding Special Education" which lists the rights of 6 parents in regards to records, confidentiality of information, 7 independent educational evaluation, notice, consent, hearings, 8 evaluation procedures, least restrictive environment, and 9 interim alternative educational setting; now, therefore, 10 11 BE IT RESOLVED by the Senate of the Twenty-fourth 12 Legislature of the State of Hawaii, Regular Session of 2008, the 13 14 House of Representatives concurring, that the DOE is urged to ensure recognition of certain rights of parents of children who 15 have been referred for special education services; and 16 17 BE IT FURTHER RESOLVED that if any of the rights listed in 18 19 the Georgia Department of Education's publication entitled, "Your Rights As Parents - Regarding Special Education," are not 20 recognized by DOE, DOE is urged to consider doing so; and 21 22 23 BE IT FURTHER RESOLVED that DOE is urged to inform all parents of children who have been referred for special education 24 services of their rights, to the best of its ability; and 25 26 27 BE IT FURTHER RESOLVED that certified copies of this 28 Concurrent Resolution be transmitted to the Chairperson of the Board of Education, Superintendent of Education, and Director of 29 Health. 30 31 32 33
