SENATE RESOLUTION

URGING THE UNITED STATES CONGRESS TO SUPPORT THE KOREA-UNITED STATES FREE TRADE AGREEMENT.

WHEREAS, South Korea is the seventh largest trading partner 1 of the United States and the sixth largest market for 2 agricultural goods; and 3 4 5 WHEREAS, investment between the United States and South Korea has been increasing, with the amount of South Korean 6 7 investment in the United States reaching \$16.7 billion and the amount of American investment in Korea reaching \$36 billion in 8 9 2006; and 10 11 WHEREAS, in 2006, bilateral trade between South Korea and the United States reached nearly \$80 billion; and 12 13 WHEREAS, the Korea-United States Free Trade Agreement 14 (KORUS FTA) represents the largest and most commercially 15 significant free trade agreement ever signed by the United 16 States in over a decade, since the ratification of the North 17 18 American Free Trade Agreement; and 19 WHEREAS, the KORUS FTA will ultimately eliminate tariff and 20 non-tariff barriers, create better jobs, enrich consumer choice, 21 boost industry, and enhance the overall welfare for both 22 nations: and 23 24 WHEREAS, the KORUS FTA will immediately eliminate tariffs 25 on almost two-thirds of United States agricultural exports, 26 worth over \$1.9 billion; and 27 28 29 WHEREAS, the KORUS FTA will liberalize the South Korean service market to United States businesses and strengthen the 30 overall transparency in key sectors, including financial 31 services, telecommunications, entertainment, legal services, and 32 express delivery; and 33 34 WHEREAS, the KORUS FTA provides state-of-the-art protection 35 of intellectual property rights, a comprehensive set of 36

strengthened protection measures for trademarks, copyrighted 1 works, and patents, as well as provides for the rigorous 2 enforcement of provisions aimed at combating piracy and 3 counterfeiting; and 4 5 WHEREAS, the KORUS FTA will provide greater American access 6 to the South Korean automobile market by the elimination of 7 South Korea's eight per cent automotive tariff, the revamping of 8 its engine displacement system, special treatment for American 9 10 automobiles on emission standards, and the expediting of the dispute settlement process with a "snap-back" mechanism; and 11 12 WHEREAS, South Korea is Hawaii's sixth largest export 13 market for goods, with nearly \$1.2 billion in bilateral trade 14 between South Korea and the United States having passed through 15 the port of Honolulu in 2006; and 16 17 18 WHEREAS, for more than half a century, South Korea and the United States have developed and maintained a dynamic and 19 comprehensive alliance and partnership, with shared commitments 20 to democracy, a market economy, and human rights; and 21 22 WHEREAS, nearly two million Americans of Korean heritage 23 and descent live in the United States and are successfully 24 engaged in numerous businesses and enterprises that would 25 directly benefit from the KORUS FTA; and 26 27 WHEREAS, in 2008, South Korea is expected to join the 28 29 United States Waiver Program and with South Korea's inclusion, it is estimated that the number of South Korean travelers to the 30 United States will double to a minimum of nearly two million 31 visitors a year, raising South Korea's stature to the third 32 largest tourism revenue generating country for the United 33 34 States; and 35 WHEREAS, South Korea is one of the staunchest and most 36 reliable allies of the United States, having deployed the third 37 largest coalition contingent to Irag and committing \$460 million 38 to post-war reconstruction efforts; and 39 40 WHEREAS, the KORUS FTA will not only boost the bilateral 41 42 economic and trade relationship between the United States and South Korea, but it will also further strengthen their alliance 43 and allow South Korea and the United States to deal effectively 44
