"A BILL FOR AN ACT RELATING TO THE STATE FIRE COUNCIL,"

begs leave to report as follows:

The purpose of this bill is to enable the State Fire Council (Council) to meet its responsibilities more effectively by authorizing the Council to hire an administrator and an administrative assistant to:

- (1) Manage the daily operations of the Council;
- (2) Administer the adoption of the State Fire Code;
- (3) Apply for and expend federal grant assistance for firerelated projects;
- (4) Conduct statewide training;
- (5) Undertake educational programs;
- (6) Collect data; and
- (7) Perform other duties as directed by the Council.



The Department of Labor and Industrial Relations, Council, Honolulu Fire Department, and Kauai Fire Department testified in support of this bill.
