Your Committee on Judiciary, to which was referred H.B. No. 670, H.D. 1, entitled:

"A BILL FOR AN ACT RELATING TO INFORMATION PRACTICES,"

begs leave to report as follows:

The purpose of this bill is to protect the confidentiality of donors and potential donors to the University of Hawaii (UH) or UH Foundation by disclosing only the name of the donor, except for those requesting anonymity, the date, amount, and purpose of the donation.

The UH Foundation testified in support of this bill. A concerned individual opposed this measure. The Office of Information Practices and a concerned individual provided comments.

Your Committee has amended this bill by:

- Removing government records disclosure provisions and (1)inserting a provision stating that this measure should not be construed to imply that the UH Foundation is a governmental or quasi-governmental agency or body; and
- Making technical, nonsubstantive amendments for clarity, (2) consistency, and style.
