RELATING TO MARINE INSURANCE.

CPC/JUD, FIN

Enacts modified version of the British Marine Insurance Act 1906, with the modifications for disclosures and warranties. Defines "marine insurance", specifies necessity of an insurable interest, requires a policy, addresses issues relating to voyage, loss and abandonment, and

indemnity.

HB 3096

RELATING TO INSURANCE.

CPC/JUD, FIN

Adopts National Association of Insurance Commissioners (NAIC) Model provisions relating to the insurers' disclosure of material financial transactions and actuarial reports. The uniform reporting requirements for all insurers is necessary to meet NAIC requirements

for accreditation.

HB 3097

RELATING TO INSURANCE.

CPC/JUD, FIN

Provides insurers with greater investment flexibility by updating the Insurance Code to reflect the investment strategies, such as stocks, bonds, and notes developed since the Code was last updated in 1987.

HB 3098

RELATING TO ACTIVITIES REGULATED BY THE INSURANCE COMMISSIONER.

Creates uniformity between other states' laws and Hawaii law in regard to licensing requirements. Increases educational requirements to keep a license, automatically inactivates a license if fees are not paid on time, allows reactivation if the fee is paid in 30 days, and broadens the types of reinsurance that can be used to meet the financial obligations of insurance agents.

RELATING TO INSURANCE.

CPC/JUD, FIN

Clarifies suspension pending a hearing requirements for actions to suspend, revoke, or refuse to renew a license. Establishes a cap on the bond amount that managing general agents are required to furnish. Requires insurers to require managing general agents's compliance with bond and errors and omissions policy requirements. Conforms financial statement filing requirements for title insurers with existing law.

RELATING TO CHARITABLE ORGANIZATIONS.

CPC/JUD, FIN

Requires charitable organizations to register with the attorney general.

HB 2309

MAKING AN APPROPRIATION RELATING TO OVERSIGHT OF

CPC/JUD, FIN

CHARITABLE ORGANIZATIONS.

Appropriates funds for the attorney general to provide more rigorous monitoring of expenditures and fundraising activities of charities.

HB 2749

RELATING TO PERSONAL INFORMATION.

CPC/JUD, FIN

Implements recommendations of the 12/2007 report of the Hawaii identity theft task force to protect the security of personal information collected and maintained by state and county government.

(Deferred from Thursday, January 31 hearing.)

HB 2252

RELATING TO INSURANCE.

CPC/JUD, FIN

Replaces the property and liability insurance guaranty association act with the National Conference of Insurance Legislators post-assessment property liability insurance guaranty association model act, which provides among other things expanded provisions on "covered claims" and replaces the association's power to cancel policies issued by insolvent insurers with immunity from pre-liquidation settlements of the insurer.

HB 2326

RELATING TO MORTGAGES.

CPC/JUD, FIN

Imposes certain restrictions on foreclosure consultants. Requires foreclosure consulting contracts to be in writing containing full disclosure of nature of consulting services to be provided, along with right to cancel. Prohibits certain acts by foreclosure consultants. Requires disclosures relating to foreclosure reconveyances and right to rescind any transfer of deed or title by homeowner. Exempts measure from "Sunrise Law" review.

HB 3088

RELATING TO RESIDENTIAL MORTGAGE PRACTICES.

CPC/JUD, FIN

Repeals the law on Mortgage Brokers and Solicitors, chapter 454, Hawaii Revised Statutes, and replaces it with a statute that provides for more specialized regulation of residential mortgage brokers, residential mortgage lenders and residential loan originators by the Division of

Financial Institutions.

HB 3104

RELATING TO THE PREVENTION OF MORTGAGE RESCUE

CPC/JUD, FIN

FRAUD.

Requires mortgage foreclosure rescuers to provide specific information and disclosures to distressed property owners as well as impose specific prohibitions on mortgage foreclosure rescuers.

(Deferred from Thursday, January 31 hearing.)
