SB 3166 RELATING TO THE HAWAII COMMUNITY DEVELOPMENT EDT/WTL

AUTHORITY.

Amends chapter 206E, HRS, to designate that at least two members of the HCDA shall be designated as the small business representatives of

the HCDA and to provide that these members shall not be prohibited

from voting on matters concerning small business in the initial designated district that they represent. Also directs the governor to initially designate the foregoing small business representatives from

the existing members of the HCDA.
