SB 3111, SD1 (SSCR2058) Testimony	RELATING TO TAXATION.  Provides an additional exemption for those with a dependent aged 18 and under with adjusted gross incomes of \$200,000 or less. Modifies and increases the child and dependent care credit. (SD1)	HSP, EDT, WAM
Status SB 3251, SD1 (SSCR2047) Testimony Status	RELATING TO EDUCATION. Establishes a task force to study the adequacy of funding for education in the State and to develop estimates and methods for meeting funding needs. Requires reports to the legislature and appropriates funds for the task force. Establishes a tax credit for volunteer services performed for the public schools or the University of Hawaii. (SD1)	EDU, EDT, WAM
SB 2660, SD1 (SSCR2042) Testimony Status	RELATING TO COLLEGE SAVINGS PROGRAMS.  Provides an annual maximum deduction of \$5,000 per individual or \$10,000 for a married couple filing jointly against their taxable income for contributions made to a section 529 college savings program in calendar year 2008 and beyond. Establishes a \$75,000 cap on the total tax deduction per college savings account. Requires Hawaii financial institutions to provide college savings account information to interested parties. SB 3127 (SSCR2041) Testimony	RELATING TO THE UNIVERSITY OF HAWAII. To increase the sources of revenue available to support the Cancer Research Center of Hawaii.	EDU, EDT, WAM
<u>Status</u> <u>SB 2300, SD1</u> ( <u>SSCR2017)</u>	RELATING TO TAXATION.  Provides a tax credit to teachers for professional development and training expenses. (SD1)	EDU, EDT, WAM
