- In person: 1 copy of their testimony to the committee clerk, Room 208, State Capitol, if delivered prior to the day of the hearing. All testimony should be **single-sided and unstapled** on 8½x11 sheets.
- By fax: Testimony may be faxed if less than 5 pages in length, to the Senate Sergeant-At-Arms Office at 586-6659 or 1-800-586-6659 (toll free for neighbor islands), at least 24 hours prior to the hearing. When faxing, please indicate to which committee the testimony is being submitted and the date and time of the hearing.
- By Email: Testimony may be emailed if less than 5 pages in length, to the Legislature's Public Access Room at <a href="mailto:testimony@capitol.hawaii.gov">testimony@capitol.hawaii.gov</a>. Please indicate to which committee the testimony is being submitted and the date and time of the hearing. Email sent to individual offices or any other Senate office will not be accepted.
- Anyone submitting testimony on the day of the hearing must make 15 copies (two-hole punched on top and, if more than one page, stapled) of their testimony and deliver to the hearing room before the hearing starts.
