# RELATING TO THE CENTER FOR NURSING.

HED/HLT, FIN

Extends the sunset date on the deposit and disbursement of certain nursing fees into the compliance resolution fund for the credit of the center for nursing special fund; establishes a staff nurse position on the advisory board of the center for nursing; requires the center for nursing to submit an interim report to the legislature regarding the five-year longitudinal study and alternative funding for the center. (SB2146 SD2)
