RELATING TO CAREGIVERS.

Amends the temporary disability insurance law to permit an eligible employee to collect up to 4 weeks of temporary disability insurance benefit payments to care for a family member with a qualifying

disability. Effective 07/01/09.

HB 2881

RELATING TO PERINATAL CARE.

HLT/HSH, HED,

FIN

Appropriates funds to continue operations and services for the perinatal clinic within the department of human services.

HB 2519

RELATING TO HEALTH CARE.

HLT, HED, FIN

Establishes the Hawaii Health Corps Program to provide student loans and physician and dentist stipends, and makes the enterprise zone business tax credit and general excise tax exemption available to physicians and dentists who practice in those enterprise zones. Requires participants in the Hawaii Health Corps Program to serve as first responders in times of civil defense or other emergencies declared by the governor.

Requires insurers that offer health care coverage to the regular employees of any group or association to offer the same coverage to part-time employees working at least 15 hours per week; insurance commissioner to report on Act's cost-benefit to the 2010 legislature; sunsets July 1, 2010. <u>HB 3095</u>	RELATING TO INSURANCE.
