rescind the contract, and prohibiting the transfer of the life insurance

RELATING TO DISPENSING OPTICIANS.

HLT, CPC

(SSCR2699) **Status** 

Specifies that a dispensing optician's license is required for the dispensing and fitting, upon written prescription, of non-corrective

contact lenses and for the sale of or offer to sell non-corrective contact

lenses. (SD1)

SB 2373, SD1 (SSCR2669) Status

RELATING TO PSEUDOEPHEDRINE SALES.

HLT, PSM, JUD

Requires electronic logs of pseudoephedrine sales to be made via an Excel worksheet provided by the department of public safety narcotics

enforcement division and maintained for two years in a form

searchable by law enforcement. (SD1)
