## AMENDED AGENDA

The agenda has been amended to add a presentation by William Haning, M.D. from the University of Hawaii, John A. Burns School of Medicine and an expert in addiction treatment. Both Dr. Haning and Alan Johnson, CEO, Hina Mauka, will present information on pharmacotherapy and addiction treatment and review the current and best future practices for addiction. The most promising medications for addiction treatment federally approved and currently on the market, will be highlighted during the briefing. The briefing will also be deleting the Representative from Alkermes.

The purpose of this informational briefing is to discuss alcoholism in Hawaii and the reasons Hawaii has one of the highest rates of drunken driving in the nation. The briefing will focus on options to reduce alcoholism and drunken driving in Hawaii (Prevention, Treatment, & Recovery).

The briefing will review the efficacy of Vivitrol<sup>1</sup>, which is a single monthly dose, 300 mg intramuscular injection to reduce the craving for alcohol. Vivitrol is for treatment of alcohol dependence in patients who are able to abstain from alcohol in an outpatient setting prior to initiation of treatment with Vivitrol. According to experts, treatment with Vivitrol should be part of a comprehensive management program that includes psychosocial support.

The Pharmacology aspect of Vivitrol will be discussed as well as results of treatment. The Family support aspect for those suffering from alcohol dependency will also be reviewed and voluntary drug treatment programs offered by employers will be reviewed as a viable solution to reduce alcohol dependency in Hawaii.

A pilot program in Hawaii, to proposal a plan of action for employers and employees, to seek treatment for alcohol dependence with Vivitrol and a good faith effort by employers to retain those employees in treatment will be discussed. Privacy policies will also be reviewed during this briefing.

Naltrexone, the active ingredient in Vivitrol, is an opioid antagonist with highest affinity for the u-opioid receptor shown to be effective in the treatment of alcohol dependence in conjunction with psychosocial support such as counseling.
