disability.

RELATING TO BRIDGE TO HOPE PROGRAM. HB 2770

> Expands the bridge to hope program to enable all heads of households receiving financial assistance and participating in first-to-work to pursue education beyond the federal limit of one-year of vocational

education.

RELATING TO PARENTAL PREFERENCES IN GOVERNMENT HB 3143

CONTRACTS, PROGRAMS, AND SERVICES.

Repeals an obsolete requirement that all State and County Executive Branch agencies and the Judiciary report to the Legislature annually identifying programs, contracts, and services that provide preference to

a parent.

RELATING TO SERIOUS OFFENSES COMMITTED BY MINORS. HB 3372

> Permits family court to commit a minor, who commits an act that constitutes sexual assault or murder, to be incarcerated at a youth correctional facility until age 18 then transferred to the custody of the

director of public safety until age 26.

HB 3379 RELATING TO DOMESTIC VIOLENCE.

> Repeals the existing offense of abuse of family or household members and separately recodifies its procedural and substantive provisions. Establishes three degrees of the offense of abuse of a family or household member. Makes conforming amendments. Effective

7/1/2008.
