SB 2857 Testimony	RELATING TO HOME CARE AGENCIES. Requires home care agencies to be licensed by the Department of Health. Appropriates funds.	HSP, WAM
SB 3164 Testimony	RELATING TO LONG-TERM CARE. Allows persons eligible to receive Medicaid funds for care at nursing home facilities to remain at home and receive home and community-based long-term care.	HSP, WAM
SB 3172 Testimony	RELATING TO RENTAL ASSISTANCE. Provides qualified rental assistance applicants up to six months to find a qualified rental dwelling.	HSP, WAM

SB 2245 Testimony	RELATING TO UNATTENDED CHILDREN IN MOTOR VEHICLES. Makes it a violation of the statewide traffic code to leave a child unattended in a motor vehicle. Effective on approval. Requires the examiner of drivers to test driver's license applicants for knowledge of this offense. Requires notice of law in rental cars. Effective on 10/1/2008.	HSP, JDL
SB 2317 Testimony	RELATING TO YOUTH PROGRAMS. Makes appropriation for the Palolo at-risk youth outreach program.	HSP, WAM
