CPC, JUD, FIN

(HSCR208-08)

Clarifies that it is not an unfair method of competition or an unfair or deceptive act or practice for an accident and health or sickness insurer

with a less than 5% market share to refuse to issue or renew a policy with a prospective insured unless the prospective insured contracts for another class or an additional policy of the same class of insurance

with the same insurer. Effective 1/1/2050. (HB2256 HD1)

HB 2186, HD1 (HSCR260-08)

RELATING TO EDUCATION.

EDN, JUD, FIN

Status

Extends from 90 days to two years of a unilateral special education placement, the time allowed for parents or guardians or the Department of Education to request an impartial hearing regarding reimbursement for the costs of a child's placement. Requires that the rules include provisions for the reimbursement of expert witness and other relevant fees and expenses associated with a hearing. (HB2186 HD1)
