WLH/EEP, JUD

Status

Authorizes the development and use of programmatic safe harbor agreements and programmatic habitat conservation plans that cover multiple landowners or a class of landowners and over a wide area or region. (SB3103 HD1)

SB 2730, SD2, HD1 (HSCR1190-08) Status RELATING TO CHILD PROTECTION.

HSH, JUD

Establishes a preference for placement of children needing child protective services. (SB2730 HD1)

SB 2886, SD1, HD1 (HSCR1272-08) Status RELATING TO CHILD ABANDONMENT.

HSH, JUD

Increases child abandonment to a class C felony and renames the offense to child abandonment in the first degree. Establishes the offense of child abandonment in the second degree and makes it a misdemeanor to abandon a child by leaving the child with a person in reckless disregard of the risk that the person's existence cannot be confirmed or the person cannot be found. Effective 7/1/2050. (SB2886 HD1)

RELATING TO PUBLIC LAND. WLH, JUD SB 2170, SD1 (HSCR1319-08) Protects counties from liability as a result of natural conditions on or near a public beach park. Eff. 7/1/2050. (SD1) <u>Status</u> The following measure was incorrectly listed on the previous hearing notice and was omitting the most recent draft and committee report. It has been corrected and is posted below. SB 1487, SD2, HD1 RELATING TO CONTROLLED SUBSTANCES. HLT, JUD (HSCR1325-08) Makes Hawaii's controlled substance laws consistent with that of federal law. (SB1487 HD1) Status The following measure was incorrectly listed on the previous hearing notice and was omitting the most recent committee report. It has been corrected and is posted below. RELATING TO PUBLIC LANDS. TRN, JUD SB 2900, SD1 Establishes that any county has the power to enforce laws and rules (HSCR1291-08) applicable to the use of public streets or highways whose ownership is Status in dispute between the State and county; ensures that the general public retains the right to use public road whose ownership is in dispute to access coastal and inland recreational areas, including beaches, shores, parks, and trails. (SD1) JUD SB 3200, SD1 RELATING TO GOVERNMENTAL RETENTION OF (SSCR2618) ATTORNEYS. Allows a department to retain an attorney if the attorney general Status declares a conflict of interest. (SD1) RELATING TO UNATTENDED CHILDREN IN MOTOR TRN, JUD SB 2245, SD1, HD1 VEHICLES. (HSCR1253-08) Makes it a violation of the statewide traffic code to leave a child **Status** unattended in a motor vehicle. Effective on approval. Requires the examiner of drivers to test driver's license applicants for knowledge of this offense. Requires notice of law in rental cars. Effective on 10/1/2008. (SB2245 HD1) HSH, JUD SB 2212, SD1, HD1 RELATING TO CRIME. (HSCR1164-08) Enables prosecution of human trafficking under Hawaii law by creating new offense of sexual exploitation of a minor, amending Status existing kidnapping, extortion, and prostitution offenses, and including sexual exploitation of a minor in definition of racketeering. Eliminates distinction between minors under 18 and minors under 16 for purposes of promoting prostitution. Makes victims of sexual exploitation of a minor and promoting prostitution in the first degree eligible for crime victim compensation. Effective 7/1/2050. (SB2212 HD1) EDN/LAB, JUD SB 2080, SD2, HD1 RELATING TO TEACHER LICENSURE.
