A ALSE VALIVES

Increases a driver's license from six to eight years; authorizes the examiner of drivers to issue a license for a shorter period if the licensee has a physical condition that may impair the ability to drive; allows the expired driver's license of a service member who is on active federal service and whose license expired while deployed outside the U.S. to remain valid for ninety days after return; applies to licenses issued after November 1, 2008. (SD1)
