HB 3273

RELATING TO TRAFFIC INFRACTIONS.

TRN, JUD

Decriminalizes violations of statutes and rules governing traffic and

parking in state harbors.

HB 2472

RELATING TO COUNTY FEES.

TRN, TAC/EEP,

FIN

Allows counties to impose resource user fee and environmental impact fees on cruise ship owners based on \$ per 500 disembarking passengers. Restricts use of fees to areas directly affected by tourism. Requires prior legislative approval before county may impose fees.

HB 2439

RELATING TO COUNTY FEES.

TRN, TAC, FIN

Allows a county to impose a service fee on a cruise ship owner if the county provides direct services to a cruise ship passenger while the

passenger is in the county.

HB 3225

RELATING TO NEIGHBORHOOD ELECTRIC VEHICLES.

TRN, JUD

Amends the definition of neighborhood electric vehicle to include vehicles with gross vehicle weight rating of less than 3,000 pounds.

HB 3203

RELATING TO COMMERCIAL DRIVERS.

TRN, JUD

Conforms Hawaii to federal law by closing a loophole that allows individuals convicted of driving under the influence to operate a commercial vehicle on a restructured commercial driver's license.

HB 3011

RELATING TO MOTOR VEHICLE REGISTRATION.

TRN, JUD

Allows for the greater flexibility in granting special motor vehicle

registration.

TRN, EDB, FIN

HB 2952

RELATING TO TRANSPORTATION.

Authorizes the Department of Transportation to establish and collect car rental customer facility charges. Creates a car rental customer facility charge special fund.

DECISION MAKING TO FOLLOW
