TRN, JUD

Establishes that any county has the power to enforce laws and rules applicable to the use of public streets or highways whose ownership is in dispute between the State and county; ensures that the general public retains the right to use public road whose ownership is in dispute to access coastal and inland recreational areas, including beaches, shores, parks, and trails.
