Prohibits public housing policies that deny rent supplement benefits based on the number of persons sharing a bedroom in an apartment or whether tenants reside in Department of Housing and Urban Development subsidized housing. Assesses a graduated antispeculation tax on the capital gains realized on real property held for less than 24 months before sold. Provides lessees under a long-term residential lease the right to purchase the fee simple title to the leased land. Directs the HPHA to expand the eligibility requirements for the family self-sufficiency program and appropriates funds therefor.
