SB 2252 Testimony	RELATING TO BOARDS AND COMMISSIONS. Prohibits ex-officio members and interim appointments of boards and commissions from appointment as chair of the board or commission.	TSG
SB 3087 Testimony	RELATING TO CONTRACTOR SUSPENSION ON PUBLIC WORKS PROJECTS. Suspends contractors found to be in violation of Chapter 104 for falsification of records or delaying an investigation under the wage and hour statute, section 104-22(b).	TSG, JDL
SB 3200 Testimony	RELATING TO GOVERNMENTAL RETENTION OF ATTORNEYS. Allows a department to retain an attorney if the attorney general declares a conflict of interest.	TSG, JDL

Increases the salaries of the Stadium Manager, the Public Utilities Commissioners, Executive Director of Hawaii Housing Finance and Development Corporation, and Civil Defense Director to be commensurate with their duties and responsibilities by linking them to 92% of the Director of Health's salary.
