The Hawaii Institute for Public Affairs ("HIPA") is a nonprofit, nonpartisan and independent research and educational organization whose mission is to provide research, analysis and recommendations on public policy issues facing Hawaii, and to provide opportunities for individuals to develop as productive leaders and citizens in society. We are a positive force that facilitates social and economic progress that benefits the people of Hawaii.

Founded in 2000, HIPA is Hawaii's first independent non-partisan and non-governmental public policy institute which conducts research and analysis on Hawaii issues, and provides a collaborative and neutral forum where issues can be thoughtfully discussed and acted upon.

2. The goals and objectives related to the request

In 2007, HIPA conducted an organizational assessment to evaluate its overall effectiveness in conducting policy research, and improving the level of public decision-making Hawaii. A list of "stakeholders" were interviewed as part of the assessment. Interviewees included board members, policy makers, and community leaders. The assessment was also intended to evaluate HIPA as it evolves from a start-up to a more stable, established entity. This snapshot generated new ideas, provided constructive criticism, created key communications strategies and helped develop new strategies for enhancing the level of public policy in our state.

The most compelling themes that emerged were:

 HIPA plays an important role in Hawaii by providing thorough, credible public policy research on key issues facing our community. HIPA reports have provided keen insight into such areas as the medically uninsured, economic diversification, sustainability and long-term care.

- There is great opportunity for HIPA to conduct follow-up activities to their
 policy studies, and create cross-sector dialogue and policy action. Using the
 data and information generated by the HIPA studies, forums and discussions
 held between groups with differing views would be invaluable in ultimately
 resolving key policy issues facing our state.
- HIPA needs to better "connect the dots" policy studies are important and HIPA's reports are extremely valuable; but the reports must also be better communicated, more widely disseminated, and better understood by the lay person.
- Legislators and policy makers want to know more, want more input into the process and want to be more engaged about some of HIPA's key policy activities.

The goals and objectives of this request are to:

- Strengthen HIPA's capacity to expand and conduct public policy research, and to further engage Hawaii's decision-makers in fact-based deliberations on public issues.
- Create programs to make HIPA policy initiatives more <u>action-oriented</u> for legislators, government officials, business leaders and other decision makers. These "connect the dot" programs include follow-up meetings, public forums, cross-sector dialogue, and facilitated sessions to enhance the probability of successful implementation.
- Develop a process that promotes new ideas and foster public policy debate on key issues facing Hawaii.

3. State the public purpose and need to be served

HIPA's mission is to elevate Hawaii's decision-making process by providing Hawaii's leaders with sound policy research and a neutral forum to resolve public issues. Having objective fact, data and analysis on public policy issues are basic requirements for the development of sound public policy. Too often, important policy decisions are based on assumptions, anecdotal evidence, biased information provided by special interests, or inconclusive and incomplete analysis of the real-life impacts of public decisions. Policy makers and community leaders should have at their finger tips sound information to evaluate important public issues. Whether it is quality research relating to the medically uninsured; the demographic and economic characteristics of Hawaii's public schools; or the fiscal impact of proposed tax policies, having objective Hawaii-specific information will significantly enhance the probability of sound policy outcomes.

4. Describe the target population to be served

There are both primary and secondary populations being served by this GIA request. The primary populations are key stakeholders and opinion leaders, including business, government, nonprofit and labor leaders who utilize policy research and data to better understand Hawaii's key public issues, and to better deliberate and recommend public policy solutions. These recipients create the policy and political context for the allocation of public resources, government action and the creation of law and public policies.

The secondary populations are direct service agencies – those organizations and individuals who are recipients of or impacted by government action. They include nonprofit organizations which provide services to the community – related to health & human services; culture & arts; advancing public education; or the myriad of public services provided by nonprofit organizations.

5. Describe the geographic coverage.

HIPA will create programs that follow-up and take action on its policy studies. In the assessment conducted, it was noted by key stakeholders that HIPA does an excellent job in creating reports that are meaningful tools for sound public policy. However, stakeholders also noted that HIPA fell short because it often did not take the reports a step further to making it action-oriented for community leaders. This grant will allow HIPA to takes its policy studies and create supportive forums for key stakeholders and communities to implement the policy recommendations outlined in the reports. For example, any of the HIPA projects listed in Section IVA below could be subject of follow-up activities. HIPA will coordinate follow-up meetings, forums, and facilitated sessions to enhance the probability of successful implementation of public policy decisions.

Key activities will include:

- Cross-sector dialogue and convenings HIPA research and report relating to healthcare, sustainability, energy, venture capital, fisheries and economic development.
- Quarterly HIPA Public Affairs Forums to key stakeholder and opinion leaders.
- Quarterly policy briefs and op-ed pieces to stimulate thought and discussion on addressing Hawaii's public issues.

Informational briefings to federal, State and county government leaders.

Mr. Kaneko is the founder, President and Chief Executive Officer of the Hawaii Institute for Public Affairs ("HIPA"), a nonprofit, nonpartisan and independent research and educational organization whose mission is to provide research, analysis and recommendations on public policy issues facing Hawaii. He is also an attorney

with the Honolulu law firm Alston Hunt Floyd & Ing, where he specializes in government relations and administrative law.

Kaneko is former National Vice President for Public Affairs and Honolulu Chapter President of the Japanese American Citizens League. He has served in many public affairs and government positions. In 1987, he was a national recipient of the CORO Foundation Fellowship in Public Affairs. From 1988 to 1993, he worked for Hawaii Governor John D. Waihee where he developed land use and housing policies for the state of Hawaii. In 1996, He initiated and implemented a national Asian Pacific American voter contact program as Director of Asian Pacific Affairs for the Democratic National Committee. He served as the primary APA liaison between the DNC and the White House, Congress, and state Legislatures. He was also a member of the U.S. Department of Justice's Office of Redress Administration Citizens Advisory Board, and was appointed to the State of Hawaii Board of Public Accountancy. He also served as an adjunct faculty member at the University of Hawaii Honors Program where he taught a course on public policy.

Kaneko received his Bachelor of Arts degree from the University of Puget Sound and his Juris Doctor degree from the Catholic University of America. Mr. Kaneko also received an honorary Doctor of Laws degree from the University of Puget Sound.

Jeanne Schultz Afuvai, Director of Public Policy

Jeanne Schultz has decades of experience in planning and implementation strategies in government and business. In public service, her work has focused on advancing economic opportunities for the people of Hawaii. Jeanne has served as executive director of the Office of Economic Development at the City & County of Honolulu, deputy director and interim director of the state Department of Business, Economic Development and Tourism and deputy director of the state Department of Transportation.

In business, she played a key role in the development of Kapolei as Oahu's second city. Jeanne served as marketing manager at the James Campbell Estate, where she oversaw all aspects of the communications/branding program from planning to collateral to market research to accomplish the Estate's goal of developing the new City of Kapolei in central Oahu. In addition, she worked for the Chamber of Commerce of Hawaii where she established the military affairs council, Alexander and Baldwin as senior vice president of marketing and Xerox Corporation as branch sales manager.

Jeanne has been honored with the "Citation for Exceptional Service in Support of National Defense" by the Association of the US Army. She earned a Bachelor of Science at the University of Wisconsin, Madison, Wisconsin.

Williams returned to Honolulu where he worked for McNeil Wilson Communications, the state's largest full-service public relations company. His clients included the Hawaii State Teachers Association, the ethanol advocacy group Clean Fuels Hawaii, the American Nurses Association, the Office of Congressman Neil Abercrombie, Architects Hawaii and Wilson Homecare among many.

He is also versed in fundraising, having worked for the University of Hawaii Foundation's communications office. Patrick earned a Bachelor of Arts from the University of California at Davis.


