# I. Background and Summary

# Brief description of the applicant's background:

Haleiwa Main Street dba North Shore Chamber of Commerce (HMS/NSCC) was established in 1985. It was supported by the Hawaii Main Street program until state funding stopped in 1997. HMS continued and is self supporting through memberships, donations, fundraising and sponsorships. With a membership of around 185, it is governed by a Board of Directors of 13 members who are very active in the organization. In 2001 the name was changed to North Shore Chamber of Commerce to serve the entire region, but the Haleiwa Main Street Program is still a core function of the organization. It has broad-based support, extensive community and business partnerships and sponsor programs, activities and community improvements that serve the local residents and an estimated 2.36 million visitors to the area annually.

Its mission is to "... promote, maintain, and encourage the historic, cultural, civic, & economic welfare of the North Shore district through research, education, advocacy and other related activities." Over the years, HMS/NSCC accomplished the following substantial tasks: created a "Made in Haleiwa" town plan; landscaped Weed Circle in partnership with the North Shore Outdoor Circle, advocated for over \$3 million for renovation of Anahulu Bridge, which was completed in 2007; was the lead agency in restoring the Waialua Courthouse for which it was nominated by HUD for its best practices; received Hawaii Tourism Authority grants for Sunset on the Beach for four years and was the event organizer for these events; conducted marketing events and activities such as creating a world-class website GoNorthShore.org; sponsors and organizes the annual Haleiwa Town Christmas Parade and Christmas Party and North Shore Kama'aina of the Year Award; and in 2006 received an USDA grant for over \$600,000 to repair aging irrigations systems on the North Shore to make agriculture more viable.

# The goals and objectives related to the request;

This project, if funded, will allow for starting the implementation of the North Shore Disaster Preparedness Plan started in 2008. It will include the participation of all the main community sectors (faith-based groups, neighborhood associations, civic groups, veterans, businesses, radio operators, and social organizations), to plan for and respond to natural and manmade disasters, the overriding goal being emergency preparedness. This

project will use community-based resources and work along side the existing city, county, and state governments and the Red Cross to help the community meet this goal of emergency preparedness and response. This project could be used as a model pilot project for the entire state in the future.

All the goals and objectives will be developed to complement and augment existing Civil Defense, Community Emergency Response Teams (CERT), Red Cross and Civilian Corps efforts and guidelines.

#### Broad Goals:

- Prepare the local population for a disaster and emergency, thus reducing the loss of life and property.
- Start to implement the draft plan by retrofitting identified high priority shelter and establish MOA's with other shelters identified.
- Start to address emergency resource needs, shelter and equipment needs and delivery

# Main Objectives:

- Continue to select and train local shelter volunteers and CERT teams using the Red Cross.
- Continue to establish Emergency Response Teams and Civilian Corps, DROP Plans.
- o Assign, train and equip evacuation teams
- Retrofit Waialua High and Intermediate for an additional 1011 hurricane shelter spaces
- Establish plans to make disaster evacuation roads to Drum Road passable.
   Establish MOA's with land owners, state and Army regarding evacuation routes.
- Establish MOA's with shelters identified, and food establishments for mass feeding.
- o Purchase cots and shelter kits for three shelters
- o Start to address communication needs
- o Refine plan, shelter teams, and operations and address additional disaster scenarios not included in year 1.

# 3. State the public purpose and need to be served;

The emergency response and public awareness needs in Hawaii are enormous and the training of local people and disaster shelter space is totally inadequate, especially on the North Shore which is more prone to tsunamis and hurricanes. During the last year Hawaii, and specifically the North Shore, have had several emergencies: forewarned is forearmed. Community organizing, training and equipping is desperately needed. Thus we propose the Hoomakaukau Program, to train second responders, a grass-roots effort spearheaded by the community and start to address the shortage of 8495 shelter spaces on the North Shore.

# 4. Describe the target population to be served;

The target population is the entire population of the district of North Shore, Oahu plus Turtle Bay Resort. If used as a pilot project, the project would also benefit the whole state of Hawaii. The population of the Haleiwa/North Shore region is estimated to be 25,000, including visitors. Faith-based organizations such as the North Shore Pastors Association, as well as denominational churches, are behind this effort, and will be included in the community partnership. Groups identified by the Civil Defense Agency as vulnerable geographically or socially will be targeted. Some groups already identified include the elderly, disabled, and non-English speaking groups, youth, and the economically disadvantaged.

Of the 25,000 population, it is estimated that one third, or at least 8,000 people, will seek shelter, or need to be evacuated. The estimated number of people needed to be shelter workers for the region, is one for every 100 people. However primary, secondary and alternate workers need to be trained (3 Deep), so the total would be 360. In addition, there would be a need for 120 Operations, Security, Emergency Operation Center, and other Emergency Response Teams bringing the total to 480 volunteers. This would be the optimal number of volunteers trained, but the minimum that will be trained is 250.

# Describe the geographic coverage;

The project area is the district of the North Shore and including Turtle Bay Resort. This represents the coastal area with all the most well-known beaches for surfing and precisely the area most likely to be hit by a tsunami or hurricane, originating in the northern or western Pacific. The NSCC, working with the City and County of Honolulu DE M, State Civil Defense and the Red Cross will train community leaders, through the business community, churches, veterans and others.

# II. Service Summary and Outcomes

- Finalize storage space for shelter supplies and equipment
- Put retrofitting of Waialua High out to bid through appropriate department
- Initiate MOA with landowner, state and Army for emergence access roads
- Initiate MOA's with other shelters and food establishments

## Phase One: Second six months

- Purchase supplies/equipment for three shelters
- Upgrade identified buildings for additional shelter space
- Finalize MOA with landowner, state and Army for emergence access roads
- Finalize MOA's with other shelters and food establishments
- Identify other needs and address in draft plan
- Refine plan, shelter teams and communications plan
- Select bid to retrofit Waialua, sign contract and initiate construction.

We will conduct a community-wide information campaign and a pre and post training questionnaires for participants to evaluate the program. Monitoring and evaluation will be conducted through hands-on exercises and drills, with each drill measured against established emergency response criteria and reviewed to improve their results. The school will be on its way to being retrofitted. Have supplies in place, MOA's signed and plan will be revised to include other disaster scenarios not included previously.

# II. Experience and Capability

#### A. Necessary Skills and Experience

The NSCC has served the community in many capacities since 1985. We are an organization with a network that covers the whole region. We act as the main community hub for information and referral and serve as a stable connection to the entire community which will help in the process of recruiting volunteers for the disaster training.

Antya Miller, Executive Director of the North Shore Chamber of Commerce, did post-graduate work in Public Administration at Penn State with an emphasis in management of non-profit organizations. She has lived and worked on the North Shore for the last 45 years and has many close ties in the community. She managed the medical clinic in Haleiwa for 20 years with four doctors and supervising 15 employees. She has worked with HMS/NSCC for the past nine years, helping to develop its programs and organizational capacity during this time and has successfully managed many grants in the past.

The project will contract with two very well-qualified professionals to carry out the project:

- 1. Leon Watson, Ph.D. has been involved in community development work for over 30 years and has been trained in emergency shelter management, community assets and natural hazard mapping. He lived on the North Shore, and has developed numerous community-based surveys and public education projects. He is a university professor, and does program and resource development work for several community based agencies and networks on Oahu and the Big Island.
- 2. Mike Reid is a certified Disaster Relief Consultant and Trainer. He has been involved in disaster planning for over 15 years, and was responsible for the training and disaster planning for the Punaluu to Kahuku communities. He is also a Human Resources Manager and has worked for the Polynesian Cultural Center since April of 1996 as a Senior Manager for training, safety and security.

#### C. Facilities

The applicant shall provide a description of its facilities and demonstrate its adequacy in relation to the request.

The NSCC's office is located in the Historic Haleiwa Gym building in Haleiwa. The gym has a capacity of 300 and there are additional meeting rooms behind the gym for smaller group meetings. The NSCC will provide office space for this

project. NSCC has adequate phone lines, computers and desk space to accommodate this project. The building meets ADA standards.


