Makakilo Baptist Church Preschool, a self-sufficient organization, began serving the Kapolei community with a half-day program for 37 children in 1976. We expanded that program, in 1980, to include a full day and a three-quarter day offering as well. Currently, 75 three to five year-olds enjoy our year-round session. The Preschool is licensed by the State of Hawaii's Department of Human Services and is accredited by the National Early Childcare Program Accreditation.

The goals and objectives related to the request;

One-time completion of an educational building, 22' -8" x 64'-0", is an integral part of our 2008-2009 construction plans. Designed specifically for preschoolers with restroom facilities, the two classrooms and separate storage area in this building are needed to update the learning environment and to provide more space for classroom activities.

3. State the public purpose and need to be served;

As Oahu's "Second City," Kapolei continues to grow with a list of 19 projects (in planning or under construction) which includes 7 retailers, 6 offices, 2 restaurants, 1 bank, 2 residential and 1 court complex. In addition, Kapolei jobs are projected to increase by 140% from the current number of 27,000 to nearly 65,000 in 2025. Without additional preschools in the planning stages, the need to continue the existing services of available providers in the Kapolei community is a necessity.

Preschool

In addition, Makakilo Baptist Church's outreach to children of all age groups is covered by weekly Awana, Youth, and Sunday School programs. Also, the lack of available facilities for non-profit groups to meet in is evident to us. Therefore we have hosted and continue to host any one or all of the following groups: Kapolei Knolls, Makakilo Hale I, Palehua Hillside, AA, Alanon, Makakilo Gardens III, Makakilo Hale II, Makakilo Mala, Makakilo Ridge, Palehua Hale, Kai Nani, Makakilo Cliffs, Oceanridge, Palehua Gardens, and Palehua Villas. We have become Kapolei's "gathering place."

4. Describe the target population to be served; and

Young, growing families will be the target population for preschool service.

Located mountainside of bustling Kapolei, our Preschool is in a unique position to serve the families of Leeward or Central Oahu.

Phase III, the Educational Building, is not within the present scope of work to be performed, however the bid proposal includes it.




