INTRODUCTION OF RESOLUTIONS

The following resolutions (H.R. Nos. 1 through 3) were announced by the Clerk and were disposed of as follows:

H.R. No. 1, entitled: "HOUSE RESOLUTION ELECTING THE VICE SPEAKER OF THE HOUSE OF REPRESENTATIVES OF THE TWENTY-FOURTH LEGISLATURE," was jointly offered by Representatives Caldwell and Finnegan.

On motion by Representative Caldwell, seconded by Representative Finnegan and carried, H.R. No. 1 was adopted with Representatives Pine and Souki being excused.

At this time, the Chair called upon Representative Chong who rose to be recognized.

H.R. No. 2, entitled: "HOUSE RESOLUTION RELATING TO THE CAUCUS LEADERS AND THE COMMITTEE ASSIGNMENTS OF THE HOUSE OF REPRESENTATIVES OF THE TWENTY-FOURTH LEGISLATURE," was jointly offered by Representatives Caldwell and Finnegan.

On motion by Representative Caldwell, seconded by Representative Finnegan and carried, H.R. No. 2 was adopted with Representatives Pine and Souki being excused.

H.R. No. 3, entitled: "HOUSE RESOLUTION AMENDING THE RULES OF THE HOUSE OF REPRESENTATIVES OF THE TWENTY-FOURTH LEGISLATURE OF THE STATE OF HAWAII AND ADOPTING OPERATING PROCEDURES FOR THE HOUSE SELECT COMMITTEE ON STANDARDS OF

CONDUCT," was jointly offered by Representatives Caldwell, B. Oshiro and Finnegan.

Representative Caldwell moved that H.R. No. 3 be adopted, seconded by Representative Finnegan.

Representative Belatti rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. I'm speaking in support of HR No. 3. I want to commend the Interim Task Force that put together these rules. I also want to commend this body for trying to adopt some change in ethics reforms that will reflect a more open and transparent procedure, particularly with the Select Committee on Standards of Conduct

"In that same vein however, I do hope that as we move forward in the experiment with this Committee that we hold ourselves with high standards and where there is a need for change, we recognize that. It is a test, and it's a great test for this House. So, thank you Mr. Speaker, in support of this Resolution."

Representative Ward rose to speak in support of the measure, stating:

"Mr. Speaker, I rise in approval of this, in favor of this. These horns outside are distracting me, but they are encouraging me to say something.

"Mr. Speaker, character is what we do when no one else is looking and I think this bill and these rules give us transparency and sheds light on what we are going to do, and I think it's going to be a great benefit. I was very impressed at much of what the task force has done based on the U.S. Senate, which fortunately for the Minority is an equal representation. When it comes to doing what's right, I don't think majority rule should be the rule of thumb.

"So thank you to the task force. Thank you to this body. I think we're going to be better for it. Thank you, Mr. Speaker."

Representative Caldwell rose to speak in support of the measure, stating:

"Mr. Speaker, brief comments of support. Much of this effort comes from all of us. As people remember, we did introduce a bill last Session, H.B. No. 1901, which was very aggressive legislation. And questions were raised. In the end though, it was because of the input we got from many members of our Caucus, both the Majority and Minority Caucuses that resulted with what you see before you today.

"And yes it is a work in progress. It's a great first step. And I think, if you look back over the history of our Legislature from the days of the Territory to when we became a State, I think it's the first time we have seen a free standing Code of Conduct Committee, and we're all to be congratulated. It's no one person. It's all of us working together. Thank you very much, Mr. Speaker."

Representative Finnegan rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. I just have short comments, but in strong support of this Resolution. I just wanted to thank everyone on this Floor for working with the body as a whole to get this Committee together. I think it speaks volumes that we do have an equal representation of Majority and Minority members, and I know that it's a big thing for this Committee. Thank you."

Representative Saiki rose to speak in support of the measure, stating:

"Mr. Speaker, I also rise in support of this Resolution. I want to thank the taskforce for all of their hard work over the interim. I want

to point out a couple of matters. I'm really not into form over substance, but I think that as this process is refined and as the rules are refined, we might want to consider a couple of points.

"One is the appointment authority for this Committee. I think it would not be unfair or unwise to allow the Minority Party to appoint their own members to this Committee. We have already allowed them to do that in other commissions that are of, or handle matters of statewide significance such as our Reapportionment Commission and our Elections Commission where we allow the Minority Party to appoint their own members, to represent their interests on those commissions.

"And the other point I want to raise is that the scope of the Committee may have to be clarified at some point because the amendment to the House Rules limits the scope of jurisdiction of the Committee, basically to violations of HRS Chapter 84 and to other violations of our Standards of Conduct. Yet the internal rules for the Committee open the door to all laws considerably of the State. I think that discrepancy may give rise to some confusion of the jurisdiction of the Committee. And we may also intrude upon other entities that have jurisdiction over all laws, other than Chapter 84 which is the Ethics Code to investigate those other statutes.

"So notwithstanding those comments, I'm very appreciative of this resolution. Thank you very much."

Representative Meyer rose, stating:

"Thank you very much, Mr. Speaker. I would like to thank the Majority Leader and the Majority Floor Leader for their leadership in our taskforce. We all worked very well together, but I would like it noted in the record that while the Majority did introduce a very comprehensive bill on ethics, it didn't pass. And the Resolution that was worked on was a Resolution that the Minority introduced late last Session and was the vehicle to get us where we are today.

"But we couldn't have done it without cooperation from both sides, and I think this says a lot for the working relationship we have and shows the public that we want to work under the highest standards possible and this gets us closer to that. Thank you, Mr. Speaker."

The motion was put to vote by the Chair and carried, and H.R. No. 3 was adopted with Representatives Pine and Souki being excused.

At this time, Representative Thielen rose to disclose a potential conflict of interest, stating:

"Thank you. Mr. Speaker. I would like to request a ruling on a blanket potential conflict of interest for Session and Committee hearings. This request would not include any matters which possibly would provide financial benefit. Thank you, Mr. Speaker. I'm the mother of the Chairperson of the Department of Land and Natural Resources, Laura H. Thielen. Thank you," and the Chair ruled, "no conflict."

Representative Ward: "Mr. Speaker, for the Members of the Small Business Caucus, or those who are supporters of small business, just a reminder: The BYOB that's going on — Bring Your Own Bills to Room 423. The signing will proceed for another short period of time. If they haven't brought their bills, hopefully they'll bring their signatures, and we will wrap that up today. Thank you."

Representative Evans: "Thank you, Mr. Speaker. As the Chair of the Heritage Caucus, I just want to remind my colleagues that in Room 423, we still have an opportunity to sign bills related to heritage and cultural preservation. Again, that's in Room 423, and we have up to 1:00. Thank you."

Representative Lee: "Mr. Speaker I would just like to remind Members that they have until 1:00 to take advantage of the opportunity to sign the Women's Caucus bills.

"On another matter, if I may. Last night there was probably the most horrific example of domestic violence which has ever occurred in my memory. A 30-year-old lady was bludgeoned to death with the butt of a rifle. I am just wondering if we could take a moment to pause in remembrance and think about what we can do in the future to prevent this from happening again."

At this time, the House of Representatives paused for a moment of silent remembrance and reflection.

Representative Caldwell: "Thank you, Mr. Speaker. I have a brief announcement. Yesterday we gathered to celebrate the opening of the Legislature. But we also gathered for another reason and that was for the birthday of one of our members. That person would be upset if I mentioned their name, but I'll give you a brief hint.

"This person exercises like a fiend every morning at Gold's Gym. This person sometimes has a goatee, or most of the time. And every so often he'll wear an earring in his ear. So I don't know if you can guess who that is, but he is one year older. I won't mention his age, and I would like to wish him a very happy birthday and I am glad that he is a member of our Caucus and a member of the House. Thank you."

Speaker Say: "You all know who the person is, right? Ok. I won't mention his name."
