The House of Representatives of the Twenty-Fourth Legislature of the State of Hawaii, Regular Session of 2008, convened at 12:11 o'clock p.m., with Vice Speaker Chong presiding.

The invocation was delivered by Representative Sharon E. Har, after which the Roll was called showing all members present with the exception of Representatives Brower, Ching, Manahan and Takumi, who were excused.

By unanimous consent, reading and approval of the Journal of the House of Representatives of the Second Day was deferred.

GOVERNOR'S MESSAGES

The following messages from the Governor (Gov. Msg. Nos. 212 and 213) were received and announced by the Clerk and were placed on file:

Gov. Msg. No. 212, dated January 18, 2008, transmitting the 2007 DBEDT Annual Report as required under Chapter 201-10, Hawaii Revised Statutes.

Gov. Msg. No. 213, dated January 16, 2008, transmitting the Report Pursuant to Section 334-15, Hawaii Revised Statutes, Requiring the Department of Health to Submit an Annual Report on the Mental Health and Substance Abuse Special Fund.

SENATE COMMUNICATIONS

The following communications from the Senate (Sen. Com. Nos. 1 through 3) were received and announced by the Clerk:

Sen. Com. No. 1, returning H.C.R. No. 1, entitled: "HOUSE CONCURRENT RESOLUTION RELATING TO RECESS DAYS FOR THE REGULAR SESSION OF 2008," which was adopted by the Senate on January 17, 2008.

Sen. Com. No. 2, returning H.C.R. No. 2, entitled: "HOUSE CONCURRENT RESOLUTION REQUESTING THE GOVERNOR TO ADDRESS THE LEGISLATURE ASSEMBLED IN JOINT SESSION," which was adopted by the Senate on January 17, 2008.

Sen. Com. No. 3, transmitting S.C.R. No. 1, entitled: "SENATE CONCURRENT RESOLUTION URGING THE UNITED STATES POSTAL SERVICE TO ISSUE A POSTAL STAMP HONORING THE WORLD WAR II JAPANESE-AMERICAN NISEI SOLDIERS," which was adopted by the Senate on January 17, 2008.

Representative Caldwell moved that S.C.R No. 1 be adopted, seconded by Representative B. Oshiro.

Representative Mizuno rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. Mr. Speaker, I rise in support of S.C.R. 1. Nisei soldiers of World War II gave ungrudgingly. Their service to our country was not a trade, but an offering. They defended our country even when many of their family members were relocated to intern camps.

"Today, many of our *nisei* World War II veterans are now in their 80s and 90s. Many have passed away, like my father and my uncle, and many died while defending our country. Our Japanese American soldiers of World War II proved their loyalty through the sacrifices they made in service to the United States.

"Mr. Speaker, the California State Assembly has a similar Concurrent Resolution and it is my understanding that their Chambers will have a Floor vote on said Resolution on Tuesday, January 22, 2008. The Illinois Legislature also has a similar Resolution, but at this time they have not scheduled it for hearing. Thus, if we pass this Resolution today, we'll be the first legislature in the nation to pass such an initiative.

"I humbly ask all Members to support S.C.R. 1. I urge the Citizens Stamp Advisory Committee and the U.S. Postmaster to issue a current postage stamp honoring our *nisei* World War II veterans, our service men and women. I would also like to commend the Senate President and the good Senator from Kaimuki/Kapahulu for supporting this most important campaign.

"And finally I would like to thank you, Mr. Speaker and leadership for allowing us this opportunity to vote on this most important Resolution to honor our *nisei* World War II service men and women. Thank you."

Representative Awana rose to speak in support of the measure, stating:

"Thank you Mr. Speaker, I stand in support. Over 300 *nisei* women also served in the United States Women's Army Corps and Cadet Nurses Corps. They should also be recognized for their bravery and loyalty to our country during World War II.

"The 100th and 442nd Regimental Combat Team's rescue of the lost battalion was acknowledged to be one of the most prominent battles in the United States Army history. This regiment led a heroic drive through German lines and suffered tremendous casualties in the Vosges Mountains in October 1944. But their drive led to the rescue and freeing of over 200 fellow American soldiers of the 36th Texas Division. The *nisei* soldiers of World War II earned over 9,000 Purple Hearts, 21 Medals of Honor and a total of nine Presidential Unit citations. I believe Mr. Speaker that they are, if not the most, one of the most decorated units.

"I think it's time that we recognize the contributions and sacrifices of our *nisei* World War II veterans and I ask Members to also support the passage of S.C.R. 1."

Representative McKelvey rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. In strong support. May I have the words of the good Representative of Kalihi entered into the record as if they were my own, except for the portion about, 'my father and uncle.' May I have that replaced with, 'many good family friends,'" and the Chair "so ordered."

Representative Marumoto, rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. I stand in favor of this Senate Concurrent Resolution. I had the pleasure of writing a letter to the Citizen's Stamp Advisory Committee on October 9, and for the record I'd like to read the letter with your permission.

To the Members of the Citizen's Stamp Advisory Committee,

As a third generation Japanese American *sansei*, I strongly believe that we should honor our greatest generation, the *nisei* of the 100th and 442nd Regimental Combat Team. A United States postal service stamp would be a most fitting tribute to recognize our amazing military achievements.

It was the second generation of Japanese immigrants that fought for their beloved country, the United States of America. They fought for their parents who immigrated to America to find a better life. They fought for those that were placed in internment camps during World War II. They fought for their children so that they could grow up with dignity. They fought for their own place in society and they fought for the honor of their people.

Please support this bright story in the history of the U.S. Army by issuing a commemorative stamp for the brave men of the 100th and 442nd. Thank you also for my children and my grandchildren, each and every one a proud American. Aloha."

Representative Ward rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker, I rise in support. Mr. Speaker, not only is this Resolution worthwhile because it gives honor where honor is due, it's also educational and historical that we remember, and not forget the sacrifices that were made. That we never forget.

"On a personal anecdotal level, I know a stamp will remind people, the young people in particular. I remember when I was in Room 442 in this building. It's now occupied by Representative Rida Cabanilla. Every time I would walk in there, I would remember the 442nd by the room number. And by this stamp, people will remember that sacrifice, and I hope someday Mr. Speaker not only the *nisei* as a group, but also the picture and profile of one very, very successful *nisei*, our Dan Inouye will be on one of these stamps. Thank you, Mr. Speaker."

Representative Karamatsu rose to speak in support of the measure, stating:

"I am in support. This stamp I believe will continue the legacy of these great soldiers. It would mean a lot to my uncle who was in the 522nd, which was attached to the 100th Battalion. It would also mean a lot to many of the friends I became close to at the Clubhouse, Club 100, especially President Arakaki and a lot of the members still alive today. I have additional remarks for the Journal. Thank you."

Representative Karamatsu's written remarks are as follows:

"I am in support. A United States postal stamp honoring the World War II Japanese-American Nisei soldiers would be a great tribute to the sacrifice they went through for the sake of future generations. They faced racism in their own country, but despite this, they valiantly fought to protect it.

"My uncle, Roy Okubo was a member of the 522nd Artillery, which was attached to the 442nd Regimental Combat Team. He is the younger brother of my grandma Bessie S. Karamatsu. I am very proud of his service that helped to better our country and world.

"I am a friend of Senator Nadao Yoshinaga who is a member of the 442nd Regimental Combat Team. After his service in World War II, he became a lawyer and elected official, and helped change discriminatory laws in Hawaii. He routinely visits me and we talk about politics, a passion we both share. It is a dream come true for me to have a mentor who was a politician from the 1954 Hawaii Democratic Revolution and a veteran of World War II. We met in 2002 and have been friends ever since.

"Finally, I have friends in the 100th Infantry Battalion such as Robert Arakaki, its current President. I got to know a number of them by volunteering at their events and hanging out with them during lunchtime at Club 100. When I am with them, I am always inspired to shoot for my dreams and do the best I can do.

"I am so honored to have these heroes in my life. I am who I am because of them. We must do all we can to continue their legacy so that their sacrifice is remembered eternally. Having a United States postage stamp honoring them would be a wonderful tribute. Thank you."

Representative Brower rose to speak in support of the measure, stating:

"In strong support, Mr. Speaker. Thank you. There have been many reasons stated why this is very important. On a personal note, my grandfather served in the 442nd, and something very interesting is that he was also interned during World War II. He and my grandmother were *nisei* Japanese Americans in the 1940s on the mainland.

"They both went to Gila River, Arizona and my mom was born in that internment camp. Eventually my grandfather was sent to Washington D.C. and he was among very few Japanese who actually discovered the death camps in Germany because of the branch of military that he was in. So I just really appreciate the strong support we've heard so far from all our Members. Thank you."

Representative Ching rose to speak in support of the measure, stating:

"Thank you, Mr. Speaker. I stand in strong support of this measure. When I used to teach in my district in Maemae Elementary School, we had the pleasure some time ago, this would have been probably ten years ago or more, we had some of the members of the 442nd come. And what we had was a course called, 'Heroes We Honor.'

"And the purpose of the course was to have young people understand that each generation has its challenges, but we have got to step up to those challenges and make the most of it. And sometimes in fact, it's a glorious thing.

"And so I think that the 442nd in particular, and the Go For Broke Foundation which I'm a member of, stands as a symbol of what courage and overcoming adversity can do for not just one generation, but those that come after. And in this time, sometimes we see in our ever-changing modern Hawaii, that maybe things are going so fast, and civility seems to be something we really need to work on, it's this hope that young people can see what those that came before them did and to honor those values. So this is exciting and I'm thankful to those introducers. Thank you."

The motion was put to vote by the Chair and carried, and S.C.R. No. 1, entitled: "URGING THE UNITED STATES POSTAL SERVICE TO ISSUE A POSTAL STAMP HONORING THE WORLD WAR II JAPANESE-AMERICAN NISEI SOLDIERS," was adopted with Representatives Manahan and Takumi being excused.
