I notice that the chairman of the committee is not here today and another member of the committee is not here today, and yet another member of the committee is not here. I see the good Senator from Pearl City. My problem with that hearing last night, Madam President, I think it may have broken your NCAA indoor continuous hearing record that you’ve held for so long now, number one. Number two, I’m wondering whether the rules of the Senate declare that after ten hours we get double time or overtime and additional holidays. Number three, we only had two breaks during the ten-hour period, although the good senator from Pearl City was in and out more often than he was talking about spaghetti and meatballs. So I’m very concerned because we’ve logged a lot of hours on that committee and I just want to be sure that we’re in full compliance with the state’s labor laws, and I would ask the chair, but of course she’s not here right now. So I just wanted to bring that to your attention, particularly the time element, Madam President. Thank you.”

ADJOURNMENT
