Chair Menor, Members of the Senate Energy and Environment Committee:

Thank you for scheduling this confirmation hearing and considering my nomination for another term on the Environmental Council. I respectfully submit the following testimony for consideration during my confirmation hearing.

#### **Current Service**

I am the current Chair of the Environmental Council and a member of the Annual Report Committee and Administrative Rules Committee. During my first term on the Council, with the Rules Committee I assisted with a complete revision of HRS 343 sections 200 and 201 (waiting for public hearing). On the Annual Report Committee I worked with David Bylund to bring more relevant and clearly presented information to the Annual Report. As a Council we held meetings on the Ala Wai Canal road improvements, Turtle Bay Resort, Hawaii Superferry, Kukui Gardens acquisition, and many other projects.

#### Background

I was born in Oregon, went to high school in Northern California and college at California State University Chico with a major in Agricultural. In 1979 I moved to Maui and soon started a marine repair business. By the mid-80's I became the Cummins dealer for Maui County responsible for Marine and Power Generation sales and service. In 1996 I started Pacific Biodiesel Inc. on Maui and built one of the first biodiesel plants in the US and Pacific Rim. As president of Pacific Biodiesel, I oversee our operations in Hawaii, Oregon and Texas, as well as construction in the US and Asia. I am a founding member of the Sustainable Biodiesel Alliance and the Hawaii Ag Alliance.

#### Goals for the Environmental Council

The Council is at a transition point. Many realize that Chapter 343 is in need of overhaul to make our environmental protection real, transparent, and functional. These changes should be made carefully as well as expeditiously. These changes may be systemic. Those of us on the Council will need to help guide the process, and take on additional responsibilities should they be deemed appropriate by the legislature.







In the process of identifying the environmental aspects of construction operations for inclusion in their company-specific EMS, GCP decided to address some of the company's concerns associated with emissions from diesel equipment. GPC has since launched a number of projects to reduce diesel emissions.

## Repower and Retrofit to Reduce Emissions



GPC replaced the engine in this rock truck.

In partnership with the American Lung Association of Hawaii, GPC received a grant in 2005 from the U.S. Environmental Protection Agency's (EPA) West Coast Collaborative to replace two generators and three engines in its quarry vehicles with Tier 1 and Tier 2 engines. Replacing the engines proved to be a big learning experience for GPC as well as the local Caterpillar (CAT) dealer, as the job required an extensive refit to satisfy the engine mounting and cooling requirements. GPC expects the

engine replacements to be complete in December 2007.

GPC is conducting emissions tests to verify the reductions seen with the new equipment, and initial results indicate that NOx emissions have been reduced by about 20 percent in the new generators. The efficiency of the new generators has reduced fuel costs considerably. As an added bonus, the new generators are so quiet, they can operate longer hours than before without receiving noise complaints.

GPC is also planning to retrofit the exhaust systems on most of its heavy-duty diesel equipment to further reduce emissions. With nearly 50 pieces of equipment targeted for diesel retrofits, GPC is poised to be the first company in Hawaii to tackle a large scale retrofit project in its rolling stock. GPC has been working closely with the City and County of Honolulu and the State Department of Education to assist them with

upcoming retrofit projects as well.

### Idle Reduction Saves Money

When GPC decided to outfit its haul fleet with a vehicle tracking system, Steele identified a system that also monitors equipment idling. Now, GPC can accurately track the amount of time each truck stands at idle in order to measure the effectiveness of its idle reduction program. The cost savings from reducing idle time goes directly into the bottom line by reducing fuel consumption and engine wear. GPC is also in the process of developing an educational video on idle reduction that GPC will require its employees to view.

### Other GPC Initiatives



GPC installed this blue smoke removal system at its Makakilo Asphalt Plant.

GPC's environmental projects are not limited to its Makakilo facility. They have recently installed blue smoke elimination systems on all three asphalt plants located on Oahu. In addition, GPC is involved in an EPA-sponsored partnership that will investigate the use of locally viable crops as a feedstock for biodiesel production. These projects will help to improve air quality in Hawaii and identify sustainable sources of

biofuel within the state.

## No Good Deed Goes Unnoticed


The leading role that GPC has played in reducing the environmental impacts of its operations has been recognized on several occasions. In 2005 and in 2007, GPC won the KOA Award for the Environment, presented by the City of Kapolei. In 2006, GPC was pleased to accept the EPA Environmental Achievement Award. That same year, GPC also won the General Contractors Association Build Hawaii Environmental Award of Excellence. The environmental awards that GPC has earned are more than just an opportunity to stand in the spotlight. According to Steele, "environmental agencies are always handing out violations and fines, but the awards are an opportunity to recognize the companies that do the right thing, and inspire other companies to step up to the plate."

## Storm Water Excellence

What's next on the agenda for GPC? Storm water management. In 2006, Steele learned of the Colorado Storm Water Excellence Program [CSEP]. This innovative program provides member companies with useful, EMS-based tools for storm water compliance at construction sites. It reduces the permitting and inspection burden on state agencies, while increasing storm water compliance within the construction industry. According to Steele, GPC wants to "take contractors to a new level of compliance and responsibility in improving storm water discharges from our construction projects." In support of this goal, GPC has laid the groundwork for establishing a

Hawaii Storm Water Excellence Program and is actively pursuing funds to begin the initial phase of the program.

Chair Menor, members of the Senate Committee on Energy and Environment, thank you for this opportunity to present background about myself in your consideration of my confirmation to the Environmental Council.

I was born in Hammond, Indiana and grew up in a small town called Black Oak near the shores of Lake Michigan. As with many of my classmates, I grew up in a family that had migrated from the farms of the southern states to the north in search of factory jobs and a better life. I attended public schools and graduated from Calumet High School. After four years in the Army, I attended and graduated from California Polytechnic State University, San Luis Obispo with a Bachelor of Science degree in Mechanical Engineering specializing in Heating, Ventilating, Air Conditioning and Refrigeration and Solar Energy Systems Design.
