Letter of Testimony - Leslie H. Kondo

My name is Gail Cosgrove. I am an attorney and have been in private practice for the last 26 years. My practice consists mostly of complex litigation, the defense of hospitals and healthcare providers in medical malpractice litigation, and product liability litigation. During the course of my career, I have also represented the City and County of Honolulu and the State of Hawaii on various matters in litigation. I am presently a member of the Judicial Arbitration Commission which oversees the Court Annexed Arbitration Program. I am also a member of the Rule 19 Committee on Judicial Performance. I am the President of the Hawaii Women's Legal Foundation which is a nonprofit organization dedicated to improving the lives of women and children in need.

I first met Les Kondo in 2005. At that time, he was the Director of the Office of Information Practices ("OIP") for the State of Hawaii. Les retained my law firm to defend OIP with respect to a lawsuit filed by the Kauai County Council. In essence, the Council sought a declaration from the Court that it was not obliged to turn over minutes from an executive session of the Council which were requested by members of the public.

Since the case is still pending, I will not get into the specifics; however, I found that Les was extremely hard-working and dedicated to his job. He studied and was well versed in the Sunshine Law and the Uniform Information Practices Act, and was particularly knowledgeable with respect to the Legislative history and intent of these laws which, at their core, favor disclosure and openness in representative government. Les could have simply turned the case over to my firm for handling; instead, he was constantly engaged and active in analyzing and preparing all aspects of our case.

I am confident that Les will continue to bring the same enthusiasm and work ethic

to serve the Public Utilities Commission as a member, and I strongly recommend that his nomination for the position be confirmed by the Senate.
