#### Dear Senator Inouye:

Thank you for your letter of February 8, 2008 requesting information regarding my nomination to the Advisory Board on Veterans' Services. I am happy to provide additional information on my nomination to assist with the confirmation process.

I understand you have my resume and listing of references on file. The only addition to my resume is that I am currently working as a Civil Defense Planner at Hawaii State Civil Defense. I would like to address your questions with the following statement:

I would like to serve on the Advisory Board on Veterans' Services for the State of Hawaii because I am a veteran of the United States Coast Guard, and wish to ensure that veterans receive the best services possible. After serving the United States in the military, I believe that the United States, and Hawaii in turn, owes veterans an efficient and compassionate delivery of benefits.

I have served on the Veteran's Advisory Board for approximately one year. From my experience on the Board, I believe it is my responsibility to review the procedures for delivery of services, and make suggestions for improvements. During my term on the Board, I have worked to successfully obtain veterans' benefits for two veterans, one a Vict Nam veteran and one Hawaii National Guardsman who served in the Iraq War.

When our Board became (and still is) concerned with the administration and admission procedures for the Yukio Otsuku Veterans Home in Hilo, I made the motion to write a letter to Tom Driskill requesting updates and information on areas of concern. The motion was accepted unanimously and I drafted the Board's letter for our chair's signature.

Three qualities and experience that I possess, which I believe benefit the Advisory Board are:

- Honorable service in the US Coast Guard. The Coast Guard is a humanitarian service and is dedicated to public service. I served for a total of 12 years with two years here in Hawaii. I received the US Coast Guard Commendation Medal for my search and rescue work in Hawaii and am credited with the saving of 157 lives and \$17 million in property here in Hawaii.
- 2) Membership in the American Veterans Empowerment and Support Community Operations (AVESCO). I have been a guest on the Hawaii Bulletin Board radio

- show, hosted by of Calvin Griffin, the Executive Director of AVESCO. The topic of our show was the situation of homeless veterans in Hawaii.
- 3) While on the Board, I have continued my support for homeless veterans. I toured the USA Vets Shelter at Kaleloa and met with the staff on needs for the program. The staff indicated a need for paint for one of the buildings. I brought this issue to our board, and subsequently a donor was found and the paint delivered to the Vets Shelter.

The only conflict I can envision for service on the Veterans' Advisory Board is my job at State Civil Defense. During emergencies, I am subject to recall. However, my supervisor is very supportive of my service on the Advisory Board and accommodates my attendance.
