Chair Taniquchi and Members of the Committee:

The Attorney General strongly supports the reappointment of Peter J. Hamasaki to the Commission to Promote Uniform Legislation of the Department of the Attorney General.

The Commission to Promote Uniform Legislation is advisory to the Attorney General and to the Legislature on matters pertaining to uniform legislation. Members of the Commission are Hawaii's representatives to the National Conference of Commissioners on Uniform State Laws. The National Conference requires that each appointed commissioner be a lawyer licensed to practice law and that each commissioner personally attend and participate in its annual meeting.

Peter J. Hamasaki is a lawyer licensed to practice law and has regularly attended and participated in the annual meetings of the National Conference and the National Conference's committee meetings. The National Conference's committee appointments are selectively made by the President of the National Conference -- not all members of the National Conference have the privilege of serving on a committee. Since his initial appointment in 2005, he has served as a member of the National Conference's Drafting Committee on Registered Agents and Annual Filing Requirements Act and the Standby Committee on Model

Registered Agents Act and Amendments to Entity Acts to Rationalize Annual Filings. He has also served, and continues to serve, as a member of the Drafting Committee to Revise the Uniform Law on Notarial Acts.

In addition to attending the meetings of the National Conference, Commissioner Hamasaki has regularly attended and participated in the meetings and activities of the Commission to Promote Uniform

Legislation. In the promotion of uniform legislation, the members of the Commission provide information on uniform laws to interested officials of the Executive Branch and to interested legislators, including presenting testimony during hearings on bills to enact new or revised uniform laws. Commissioner Hamasaki has provided information and testimony on bills to enact the Revised Uniform Securities Act, the Uniform Athlete Agents Act, and the Uniform Real Property Electronic Recording Act and has on several occasions volunteered to appear and provide information for other commissioners when the other commissioners have had conflicting commitments.

In view of his demonstrated commitment to the promotion of uniform legislation and his continuing participation in the activities of the National Conference and of the Commission to Promote Uniform Legislation, the continued service of Peter J. Hamasaki as a member of the Commission and of the National Conference will be greatly beneficial to the State of Hawaii and the National Conference. Consequently, the Attorney General respectfully requests that this Committee recommend the immediate confirmation of the reappointment of Peter J. Hamasaki to the Commission to Promote Uniform Legislation.

I am pleased to submit this testimony in support of the nomination of PETER

J. HAMASAKI to serve another term on Hawaii's Commission to Promote Uniform

Legislation ("CPUL").

All of the commissioners on the CPUL serve as commissioners to the Uniform Law Commission ("ULC"), also known as the National Conference of Commissioners on Uniform State Laws, which is a body of attorneys from all States who spend countless hours to develop proposed laws to be enacted in all States. ULC's goal is to provide uniformity in the laws among the States without sacrificing control to the federal government. The best known products of ULC include the Uniform Commercial Code, the Uniform Probate Code, the Uniform Transfers to Minors Act and the Uniform Partnership Act, all of which have been adopted in Hawaii; these and other uniform laws affect the lives of residents of Hawaii and other States every single day.

A commissioner's duties are two-fold: First, the commissioner needs to participate in the drafting of uniform laws, including the careful review and consideration of their provisions on a line by line basis. Secondly, the commissioner needs to work with the legislature of his or her State to get uniform laws enacted.

As a fellow commissioner on the CPUL, I have observed firsthand how well Peter has fulfilled those duties. He carefully studies the drafts of the various acts that are considered at the annual summer meetings of ULC, and during his first term as a commissioner, he was appointed by the Executive Committee of ULC to serve on the drafting committees for the Model Registered Agents Act and the revision of the Uniform

Law on Notarial Acts. Members of a drafting committee attend additional meetings during the year to discuss and draft new acts for presentation to all the commissioners at the annual summer meetings.

Peter also prepares testimony in support of uniform acts which have been introduced in the Hawaii Legislature, testifies at hearings and reports his evaluation of the comments and status of the bills to the CPUL. He often volunteers to assist other commissioners on the CPUL who have scheduling conflicts with respect to hearings on bills that they are following. Additionally, Peter has contacted individuals and groups who may be interested in particular uniform acts and done research to provide background information to those interested parties as well as the CPUL.

I have no reservation in supporting the nomination of Peter J. Hamasaki for an additional term on the CPUL. Peter has been and will continue to be an outstanding commissioner on the CPUL, and I urge you to recommend that the Senate confirm his nomination.


