Chair Taniguchi and Members of the Committee:

The Attorney General strongly supports the reappointment of Kevin P.H. Sumida to the Commission to Promote Uniform Legislation of the Department of the Attorney General.

The Commission to Promote Uniform Legislation is advisory to the Attorney General and to the Legislature on matters pertaining to uniform legislation. Members of the Commission are Hawaii's representatives to the National Conference of Commissioners on Uniform State Laws. The National Conference requires that each appointed commissioner be a lawyer licensed to practice law and that each commissioner personally attend and participate in its annual meeting.

Kevin P.H. Sumida is a lawyer licensed to practice law and has regularly attended and participated in the annual meetings of the National Conference and the National Conference's committee meetings. The National Conference's committee appointments are selectively made by the President of the National Conference — not all members of the National Conference have the privilege of serving on a committee. Since his initial appointment in 2005, Commissioner Sumida has served as a member of the National Conference's Drafting Committee on a Uniform Limited Cooperative Association Act and the Standby Committee

on a Uniform Limited Cooperative Association Act. He has also served, and continues to serve, as a member of the National Conference's Drafting Committee on the Unsworn Foreign Declarations Act. He has diligently performed his duties as a uniform law commissioner. During the 2007 annual meeting, Commissioner Sumida participated in the drafting committee presentations of the Uniform Limited Cooperative Association Act on Saturday morning, July 28, and of the Unsworn Foreign Declarations Act on Sunday morning, July 29, and left Sunday afternoon to return to Honolulu for a court appearance on Monday in his private practice of law.

In addition to attending the meetings of the National Conference, Commissioner Sumida has regularly attended and participated in the meetings and activities of the Commission to Promote Uniform

Legislation. In the promotion of uniform legislation, the members of the Commission provide information on uniform laws to interested officials of the Executive Branch and to interested legislators, including presenting testimony during hearings on bills to enact new or revised uniform laws. Commissioner Sumida provided information and testimony on a bill to enact the Uniform Environmental Covenants Act during the regular session of 2006, which uniform law was enacted and codified as chapter 508C, Hawaii Revised Statutes.

During his first term of appointment, Kevin P.H. Sumida has demonstrated his commitment to the promotion of uniform legislation. He has been and will continue to be a valuable member of the Commission to Promote Uniform Legislation and of the National Conference and his continued participation will be greatly beneficial to the State of Hawaii and the National Conference. Consequently, the Attorney General respectfully requests that this Committee recommend the immediate confirmation of the reappointment of Kevin P.H. Sumida to the Commission to Promote Uniform Legislation.

It is with great pleasure that I submit this testimony in support of the nomination of KEVIN P. H. SUMIDA to serve another term on Hawaii's Commission to Promote Uniform Legislation ("CPUL").

All of the commissioners on the CPUL serve as commissioners to the Uniform Law Commission ("ULC"), also known as the National Conference of Commissioners on Uniform State Laws, which is a body of attorneys from all States who spend countless hours to develop proposed laws to be enacted in all States. ULC's goal is to provide uniformity in the laws among the States without sacrificing control to the federal government. The best known products of ULC include the Uniform Commercial Code, the Uniform Probate Code, the Uniform Transfers to Minors Act and the Uniform Partnership Act, all of which have been adopted in Hawaii; these and other uniform laws affect the lives of residents of Hawaii and other States every single day.

A commissioner's duties are two-fold: First, the commissioner needs to participate in the drafting of uniform laws, including the careful review and consideration of their provisions on a line by line basis. Secondly, the commissioner needs to work with the legislature of his or her State to get uniform laws enacted.

Being a fellow commissioner on the CPUL, I have observed how conscientiously Kevin has fulfilled those duties. He often contributes to the floor debate on the various acts that are considered at the annual summer meetings of ULC, and during his first term as a commissioner, he was appointed by the Executive Committee of ULC to serve on the drafting committees for the Uniform Limited Cooperative Association Act and

the Unsworn Foreign Declarations Act. Members of a drafting committee attend additional meetings during the year to discuss and draft new acts for presentation to all the commissioners at the annual summer meetings. Kevin has also been actively involved in preparing testimony for uniform acts which have been introduced in the Hawaii Legislature, and in testifying at hearings in support of the acts.

Like all ULC commissioners, Kevin volunteers the time he spends on ULC activities. This is a particularly significant commitment for a full time practitioner in a small law firm.

Kevin has been and will continue to be an outstanding commissioner on the CPUL. I have no reservation in supporting the nomination of Kevin P. H. Sumida for an additional term on the CPUL, and I urge you to recommend that the Senate confirm his nomination.
