My name is Ronald Boyer, Deputy Director of the Department of Commerce and Consumer Affairs ("Department"). The Department appreciates the opportunity to provide testimony on Governor's Message No. 562, regarding the appointment of Thomas T. Ueno to the Board of Accountancy ("Board"). The Department supports Mr. Ueno's appointment and respectfully requests that the Committee recommend that the Senate advise and consent to his appointment to the Board.

Mr. Ueno has also served our nation as a member of the Hawai'i Army National Guard.
