NEEDED Statistics do not only help and benefit our certified blind, deaf, deaf- blind and handicapped, but also those who want to get our votes. So far not even the board of Health, Ho'opono nor other Blind, Deaf, Deaf-Blind or other Handicapped Agencies have ANY reliable or reasonable statistics about us.

Kathy Reimers, Hawaii Services on Deafness executive director, quoted 100,000 deaf persons and increasing with the elder population. Ho'opono only quoted 3,340 blind persons who are registered with them as tip of the iceberg. Why is it more important to report every imaginable VENERAL DISEASE, rather than the legally certified blind, deaf and handicapped???

Maybe you could also consider, to substitute our hardly used, but expensive voting machines with an outreach program for absentee ballots for us. Maybe you can combine our Kapuna ID from the City with a FREE Voter Registration State ID to gather the votes for you, since most of us cannot have a State Drivers License. The BIG Savings on the rarely used Voting Machines for Handicapped could more than pay for it. A FREE High-Speed inter-net access could also be used to reach the homebound for their votes and to communicate with us. That would also double up in Savings on needed Education that would make useful Taxpayers out of us as writers and data entry jobs. Most Deaf can SEE and most blind can HEAR with the loudly reading and enlarging Zoom-Text program! Presently The State pays about \$75.- per hour for each of the required 2 or 3 ASL interpreters. The Federal Government also Subsidizes our Video Relay Services with nearly \$7.- per minute but NO FREE HIGH SPEED INTERNET ACCESS TO USE THEIR "FREE" cameras. Don't you think that FREE High-Speed Inter-net access would be a big money saver and help in our ailing education programs? Especially when your statistics indicate that twice as many or 200% more deaf blind and handicapped get 200% more information from the inter-net than regular users

AGAIN, we need STATISTICS to see how very few Deaf are using ASL and how very few Blind can read and write Braille. Most can train them selves on Computers through FREE High-Speed Inter-net access. Heinz-Guenther Pink
