- Department's Position: The Department of Health and the Executive Office on Aging appreciate
- the intent of HB 2195 to increase funding for KUPUNA CARE to ensure that the needs of older
- adults and their family caregivers are maintained. We note that the proposed appropriation is
- 4 outside the Executive supplemental budget.
- 5 **Fiscal Implications:** \$500,000 of general funds to be appropriated for state fiscal year 2008-
- 6 2009.
- 7 **Purpose and Justification:** HB 2195 appropriates increased funding for KUPUNA CARE to
- 8 ensure that the needs of older adults and their family caregivers are maintained. The proposed
- 9 appropriation is designed to increase the reach of services such as adult day care, respite care
- assisted transportation, attendant care, case management chore, home-delivered meals,
- 11 homemaker, transportation and personal care.
- EOA respectfully requests the deletion of the sentence on page 2, line 4 5 which reads,
- "Kupuna Care offers a reduced rate for those who can afford to pay only a portion of the service."
- This practice previously referred to as "cost share," was part of the original design in 1999, but

- was eliminated in 2005. In addition, we ask that the term "donation" on line 6 be replaced with
- 2 "contribution." The term "voluntary contributions" would be consistent with the federally funded
- 3 services also funded in KUPUNA CARE program.
- 4 It should be noted that Act 204, SLH 2007, already appropriated an additional \$525,000 to EOA
- 5 for Kupuna Care services in fiscal year 2008-2009.
- 6 Thank you for the opportunity to testify.



Chair Shimabukuro and Members of the House HSH Committee:

I am Lucy Lessard, P.T., member of the Hawaii Chapter – American Physical Therapy Association, and Chair of the Legislative Committee. The Hawaii Chapter – American Physical Therapy Association (HAPTA) is comprised of 300 member physical therapists and physical therapist assistants employed in hospitals and health care facilities, the Department of Education school system, and private practice. We are part of the spectrum of care for Hawaii, and provide rehabilitative services for infants and children, youth, adults and the elderly. Rehabilitative services are a vital part of restoring optimum functioning from neuromusculoskeletal injuries and impairments.

HAPTA supports this measure that appropriates funds to continue the Kupuna Care program. Physical therapists have an inherent interest in maintaining the independent function of our elder citizens. It is our society's best interest to keep people functioning in their home and reserve long-term care beds for those who cannot function in their homes, with or without support services. Many of our elders rely on help from family and those outside services to maintain their quality of life in their own or family's homes.

The Kupuna Care program is central to the maintenance of function of those who are not completely independent. This is a program that is increasingly more necessary as our population ages and long-term beds are in acute shortage.

Catholic Charities Hawaii (CCH), is a tax exempt, non-profit agency that has been providing social services in Hawaii for over 60 years. The Agency has also been providing supportive home and community based services to elders since 1973 and currently serves approximately 5,000 older persons each year. We strongly support HB 2195, Relating to Aging, which would provide an additional \$500,000 for Kupuna Care and recommend that the funding base for Kupuna Care in the Executive Office on Aging (HTH904) budget be increased by this amount.

Catholic Charities Hawaii has provided transportation and housekeeping services, both State-funded Kupuna Care Services, for a number of years. In addition, we have been partners with other aging network providers who also provide essential State-funded Kupuna Care Services such as home-delivered meals, case management, bathing service and more.

State-funded Kupuna Care currently funds a set of basic, essential services that help frail elders remain independent and avoid institutionalization or homelessness. In addition, these services support family caregivers who are providing support to frail elderly relatives who still want to maintain their independence but require supportive services, from family and the community, in order to do so.

Some of the challenges that Catholic Charities Hawaii faces in providing State-funded Kupuna Care Services include:

- Flat or reduced Federal funding for elderly services.
- Continued wait list for Housekeeping Services which means elders who may be at risk of eviction must wait for several months in order to receive services.
- Increased gas expense which hampers our ability to provide transportation that enables seniors to access needed services. This particularly impacts our ability to serve rural elders who need to get to medical and other appointments in town.

The Consequences of Not Providing More Funding for State Kupuna Care Services

- Wait lists will grow. The longer that elders must wait for service, the greater the risk that their will lose their ability to live independently in a safe, dignified environment.
- The alternative is institutionalization at a cost of approximately \$7,000 a month per person. Additional funding of \$500,000 for State Kupuna Care will provide additional services for hundreds of seniors. This same amount could only support about six elders in nursing homes for a year. The cost of institutional care will eventually be a burden on taxpayers and government since State-funded Kupuna Care program targets those in greatest need.

POSITION: PABEA supports HB 2195 to appropriate additional funding for the Kupuna

Care program.

RATIONALE:

I am offering testimony on behalf of PABEA, the Policy Advisory Board for Elder Affairs, which is an appointed board tasked with advising the Executive Office on Aging (EOA). My testimony does not represent the views of the EOA but of the Board. I am also a professor of medical sociology at UH-Manoa who has worked with elderly services in Hawaii for more than 20 years.

- The population of Hawaii is aging rapidly and there is general consensus that we face a significant challenge to assure appropriate care to the frail elderly. Kupuna Care provides a range of services for frail elders living at home and their caregivers. There is a strong preference for individuals to remain at home for as long as possible, and the number of institutional beds is not likely to grow significantly.
- The need for the services of the Kupuna Care program is growing rapidly but the funding has not kept pace with the growth, resulting in long wait-lists for many services;
- Reimbursements have been flat for many years even though the costs of providing services has increased. Kupuna Care is having more difficulty finding providers willing to provide services, and thus the reimbursements need to increase to keep pace with costs.
- The Joint Legislative Taskforce on Family Caregiving is asking Kupuna Care to develop additional services to support family caregivers, provide emergency respite, provide grants for home modification, and provide financial assistance. Additional funding is needed in order to provided these needed services.
