Chairs Menor and English, Vice Chairs Hooser and Gabbard and Committee Members:

The Downtown Neighborhood Board strongly supports HB 2263 authorizing the Director of Transportation to draft administrative rules to limit noise allowed for commercial vessels using state harbor facilities.

The Downtown and Chinatown areas have several residential buildings very near the mauka portions of Honolulu Harbor. Our board has received a number of complaints about excessive noise, usually caused by electric motor-generators used to provide power to moored vessels for lighting and refrigeration on a 24-hour basis.

In attempting to accurately measure the noise level, we found that no state or City & County agency has responsibility for enforcement of noise from the harbor area. County Liquor Commissions measure and enforce noise levels from licensed liquor establishments, County Police Departments can determine if excessive noise is coming from residential or commercial units not serving liquor, and the Noise, Indoor Air Quality and Radiation Branch in DOH is responsible for regulating noise from ground-based commercial, construction and industrial activities. None of these agencies can do the same for vessels in harbors.

Our concern is not with occasional boat whistles or public address systems on passenger vessels, it is the noise from maintenance work or power generators that occur in the evening or continually all day and night that is so disturbing.

This measure will simply allow DOT to draft rules covering these harbor situations with enforcement likely by DOH. It will close an enforcement gap and help ensure that our residents near all state harbors can have some peace and guiet!
