Chair Cabanilla, Vice Chair Awana and Members of the House Committee on International Affairs.

The Department of Business, Economic Development, and Tourism (DBEDT) supports the concept of HB 2321, which establishes a peace mission committee within the Office of International Affairs (OIA) of DBEDT and appropriates funds for the committee's activities and programs. There have been many good ideas introduced this legislative session that support the State's economic development goals. We hope the legislature will see it fit to support, pass and fund these ideas, together with the priorities of the Executive's Supplemental Budget.

DBEDT, through the OIA, has placed a high priority on implementing the Hawaii Global Links program, the objective of which is to prepare Hawaii's residents for the global economy.

The OIA emphasizes international trade, cultural and educational exchange activities, all which

lead to the better understanding of other people and cultures. Through the interchange of people, products and ideas, international peace based activities would be a natural outgrowth. The proposed peace mission committee and funding of \$500,000 for fiscal year 2008-2009, as specified in the bill, would be instrumental in helping the OIA to expand its existing business, cultural and educational priorities to include peace initiatives and activities. Without this funding, DBEDT is unable to expand beyond what it is currently doing with regards to the OIA.
