TESTIMONY

My name is Tony Costa and I am testifying on behalf of Hawaii Near Shore Fishermen, a loosely organized, tight-knit group of nearshore fishermen.

HB2687 would require the department of land and natural resources to review rules adopted though chapter 91 for effectiveness.

Hawaii Nearshore Fishermen are in SUPPORT OF HB2687

Last year, the fishermen were in support of a bill that asked that a scientific need be demonstrated before fishing restrictions are implemented – the current environmental trend being a "precautionary approach" promises to gradually move in a complete "no take" direction with respect to fisheries.

Fishermen felt, and continue to feel, that arbitrary regulations using this precautionary approach is not sustainable. More importantly, when this precautionary approach is singularly applied to fishing only, it could indeed be going way to far – and at stake, the baby goes out with the bath water. A sustainable life style and cultural practice deeply part of this community forever lost.

Each new <permanent> fishing restriction implemented moves us closer to a time of complete no fishing.

HOUSE BILL NO. 2687 Relating to Aquatic Resources

Representative Ito, Representative Karamatsu, members of the committee, my name is Linda Paul and I am testifying today in behalf of the Ocean Law & Policy Institute of the Pacific Forum CSIS. I am testifying against HB 2687, which is yet another poorly-disguised attempt by a particular ocean resources user group to undermine and undo DLNR's rule-making authority.

It also puts the Legislature back into the business of micro managing fisheries, a task that is impossible for it to do since it is only in session 60 very busy days of the year, and a task which it wisely turned over to DLNR in 1999 when it recognized that our aquatic resources need managing 365 days a year. The rule-making process, as opposed to the legislative process, provides far more opportunity for public input and comment and results in rules that reflect the needs and desires of a whole spectrum of aquatic resource user groups.

It is important to understand that even with a complete closure of a fishery, the stock may not recover within a three year time period. A good example of this is the lobster fishery in the Northwestern Hawaiian Islands. That fishery was closed eight years ago and it still has not

recovered.
