Chair Baker and Members of the Committee:

I am Ken H. Takayama, Acting Director of the Legislative Reference Bureau. Thank you very much for this opportunity to testify in support of H.B. 2688, H.D. 1, which appropriates funds for the legislative branch of the state government.

Section 9 of the measure appropriates \$3,449,623 for the operations of the Bureau during fiscal year 2008-2009. I believe this amount will be adequate to enable the Bureau to carry out our duties and responsibilities in the coming year. I understand that this amount also includes approximately \$85,000 which the Bureau will be directed to pay to the Council of State Governments (CSG) to cover the State's dues.

Section 10 of the measure directs the Bureau to contract with the University of Hawaii for a study on the State's environmental review process. Having the option to contract with the University of Hawaii through the Research Corporation of the University of Hawaii (RCUH) may help to expedite matters. For this reason, a statement in the committee report clarifying the acceptability of using this alternative would be beneficial.
