NOT SUPPORT - HB2735: Relating to Public Housing; Security Appropriation

Aloha Chair Chun Oakland, Vice Chair Ihara Jr. and members of the committee:

My name is Kanani Kaaiawahia Bulawan. I'm a Kanaka Maoli, a Private Citizen and an ex-tenant to public housing. I'm here testifying **NOT IN SUPPORT** to **HB2735 relating to Public Housing, Security Appropriation**, allowing HPHA to increase private security services in public housing primarily for Mayor Wright Housing.

My testimony provides experiences as I've introduced who I am. First, as a Kanaka Maoli or what you would call a private citizen, I'm concerned and appalled to accept the fact that up until now the laws in place which addresses public safety would not apply or be limited to enforce in public housing communities. How can this be if we accept that public (subsidized) housing is responsible for housing qualified public citizens, the communities would not be defined as "Public Property"?

Second as my experience when I lived in Mayor Wright Housing back in 1958-1980, there has always been some form of "gang activity" in the community. The illegal activities were monitored and aided by law enforcement for any and all violations of law whether the incident was during "business" or "non-business" hours, most importantly on public housing property or on open streets. What has changed since that time? The bill reports that this was a Weed and Seed community, why has it not been enforced? Making a measure of this sort will only allow the management to avoid the core problem that is happening ALL AROUND THE AREA AND COMMUNITIES IN WHICH THE LEVEL OF PROVERTY IS HIGH. Whether or not these housing communities have private security or public law enforcement support, the core issue is how do these services enforce laws that keep our

community safe? There will never be enough funds to afford any type of extended security systems other than community-based group initiatives as like what the Weed and Seed program offered. The leverage and authority in public housing is the management and how serious they are in the enforcement of rules and violations, implementing forms of action that includes evictions and possible persecution. The public has the right to be safe in decent and healthy neighborhoods.

In recap, if public housing is for the betterment of its qualified citizens and should be given safe, decent and healthy housing why isn't that the priority and enforcement an issue? Earlier testimonies offered by residents of the housing community, the neighbors of the street and the director of Public Housing all indicate that there is a need to increase security services. If this housing community is in need, what are the conditions and situations of other housing communities of the same qualified population? This will set a preference for all housing communities to request and obtain additional appropriations for security services. Again even with these increase security services, what is the power to follow up and make immediate arrest? The measure DOES NOT address this.

Maybe this measure should be amended to include a process in which the security services will have powers to enforce arrest, trespass orders and possibilities of eviction.

The bill only identifies concerns and possible solution about illegal activities in the housing community; it DOES NOT identify the concerns and solutions in addressing the barriers to assuring we have a healthier community and thereby reducing the need for continued government interventions. The management of Public Housing needs to assure they are able to enforce measures that can lead to evictions and allow that authority to the present security contractor.
