## Aloha kakou,

As the Maui County Executive on Aging, I consider the Director of the Executive Office on Aging (EOA) a colleague and peer. I say this because the Aging Network, as it has been developed since the passage of the Older Americans Act of 1965, has evolved into a finely tuned, tripartite intergovernmental partnership that is statewide and effective, down to the community level. In Hawai'i, as in most other states, the EOA is the head of this network. As such, its head convenes many of our executive and administrative-level meetings and discussions, allowing our state to be in compliance with several important federal mandates. More importantly, the federal Administration on Aging (AoA), liaisons with this head, so as to effectuate federal public policy and administrative rules, as it affects aging and older persons down to the county and community levels. I support H.B. 2775, which increases the salary cap for the Director of the EOA to bring the salary more in line with my own, as a county-level Administrator and to keep state-level administration and leadership that is vibrant, innovative and mutually accountable.
