- 6. Those opposed to law enforcement possessing and using Ta few hundred deaths attributed to Taser incidents and bring I liability issue. Currently there is no conclusive data to prove viable nexus to being tased and may have been the result of poor health or drug/alcohol intoxication. Not having the Tas is now common and standard for modern day law enforcem vicarious liability for the employing agency if it opposes the officers as an additional safety measure. It seems far less of carrying and using firearms.
- 7. Many of our DOCARE officers are senior in age largely dupractices and the advanced age required for retirement. The officer can be very physically demanding. They often work remote terrain, in all types of weather conditions and sea stebe non-existent and the radio communications are poor at be is no radio on Oahu, period! For these reasons the Taser and threat of using a Taser on a non compliant subject greatly er safety during such an encounter.
- 8. In the 90's, a National Park Service Law Enforcement Rang was attacked, subdued and ultimately shot and killed with h assailant. He was highly trained at the Federal Law Enforce in the use of both lethal and non-lethal weapons. He was ph later determined that he applied his defensive tactics trainin pepper spray and a collapsible baton to resist the attack. Stil killed by the deranged man when he simply told the man to rumored that DOCARE officers on the Big Island had prior same assailant. The National Park Service now issues many Enforcement Rangers with Tasers as an additional tool designificers in such a situation.
