TESTIMONY OF THE CHAIRPERSON OF THE BOARD OF LAND AND NATURAL RESOURCES

On House Bill 3260 – RELATING TO FISHING

BEFORE THE HOUSE COMMITTEE ON WATER, LAND, OCEAN RESOURCES, AND HAWAIIAN AFFAIRS

February 13, 2008

House Bill 3260 would establish bag limits of two fish per day for seven species of parrotfish (uhu) and two fish per day each, of three species of goatfish (kumu, munu, moano ukali) regardless if for commercial or non-commercial purposes. This bill would also establish a minimum size for take of kumu, munu, moano ukali of 10 inches in length, and any uhu no less than 12 inches in length. While the Department of Land and Natural Resources (Department) supports the intent of this measure, the Department prefers developing new harvest restrictions through the administrative rules process.

Act 151, Session Laws of Hawaii 2002, that transferred many of the marine life regulations from statutes to Department administrative rules. The Department argued, and the Legislature agreed, that the creation of regulations for such matters as minimum sizes, seasons, bag limits, etc. were better handled through the administrative rules process.

The Department is currently evaluating many marine species in need of further conservation, and will be presenting its findings through a series of public meetings very shortly. At those meetings, fishers will be asked for their input for a number of marine species being considered. Consideration will include: minimum sizes, bag limits, restrictions on take based on commercial or non-commercial purposes. Public informational meetings are expected to be completed in 2008 with new rules established by 2009.

The Department would also be pursuing new rules on these marine species from a more regional, community approach. As a result, the Department envisions that the take of important marine fish and shellfish will be developed in concert with local values and traditions, while at the same time trying to maintain consistency and sustainability. In this way the Department hopes to gain broader support for such fishing rules and thus greater compliance.

The Department therefore respectfully asks the Legislature's support for the Department to continue its efforts to promulgate these proposals through administrative rules.

Respected Representative,

Having seen quite a few reefs around the world, one of the most typical characteristics of those in Hawaii is that that they're silent. Wherever you visit a reef in other parts of the world, you can hear parrotfish scraping away at the reef, keeping it clean from algae that would otherwise overgrow and kill corals, eventually causing the whole reef, and all organisms that depend on it to collapse. This is not an apocalyptic doom scenario, it has actually happened in many places, especially in the Caribbean. Realizing their mistake to overharvest organisms like parrotfish that play a crucial role in maintaining the health of the wider reef ecosystems, millions are currently spent to reverse the collapse of whole reef ecosystems against which many had warned for a long time. Increased microbial loads, loss of aesthetic value, biological productivity, fishing possibilities and tourist revenue followed and there is hardly any evidence that this trajectory of decline can be rever

While the workings of reef ecosystems are not well known and differ from one place to another, many have observed how seemingly small changes to them can have profound effects. The adding of an invasive species or the removal of what scientists call "ecosystem engineers" (such as parrotfish and corals) will inevitably cause some form of reef meltdown. Some require actual proof on how this dynamic will play itself out and when such proof cannot be delivered, the scenario described above is deemed unlikely. These are the people that are scratching their heads right now in the Caribbean. They realize, too late, that desiring actual proof in a situation where commonsense could have worked just as fine, has cost them dearly. Needless to mention that the costs associated with reef recovery greatly exceed the money earned from depleting these resources in the first place. I now wonder whether Hawaii is about to make the same mistake.

Everyone who has been on the islands for more than 10 years talks about the lower number of Uhu that swarm the reef, making it increasingly more difficult to keep out in a natural way what shouldn't be there. Keeping excessive algal and microbial growth under control is a task that we, as humans, will never be able to take over. Algal problems in various places of the state indicate that control of algae by herbivores, such as parrotfish,

is already breaking down. The subsequent decline in reef health comes with unnatural changes in microbial communities, and the prevalence of Staph infections these days should be regarded as another (common-sense) indicator that reefs are changing in a direction from which no one will or can benefit.

An obvious decision to contribute to the prevention of these problems would be to leave the parrotfish to their work, keeping the reef healthy and for us to enjoy. Certainly one should not stop old fishing traditions, but I want to stress the word "old". Semi-industrial fishing for parrotfish on the islands' north shores where 1000's of pounds of parrotfish are taken using unsportsmanlike collection methods (i.e. spear fishing using SCUBA gear at night when parrotfish are sleeping) does not remind me of the old-days when people took what they needed. I am not in a position to judge or tell people what to do, but I do want to point out that the reef decline that has been observed by those on the island for more than a few years will certainly not become easier to reverse if such practices continue. One doesn't have to be a scientist to understand how this works or see the benefits of a conservative approach when it comes to protecting the foundation that supports Hawaii's tou

rism and traditional fisheries on which the income of many depends. Will the excessive taking of parrotfish be the straw that breaks the camel's back and be the last stressor that needs to be added to ensure a rapid collapse of Hawaiian reefs? It has certainly happened elsewhere.

Efforts by local fishermen to protect these fishes therefore deserve all support. It is them, who probably know best how the number of parrotfish has gone down over the last decades. In other words, those who recently showed up have no historic baseline to which to compare present day parrotfish abundance and might consider the current situation as "normal". Fishermen do see long-term trends. Local actions as the one described above have taken the form of proposing a bill (HB3260) to limit the taking of parrotfish and I suggest we follow their insight. It would be naive not to trust those who know best and make the same mistake that has been made in so many other tropical locations that faced these issues in the past. They did not act and it has cost them dearly in an ecological, economic and cultural sense, and so will it to Hawaii. The old Hawaiian traditions allowed for the protection of natural resources once these were threatened and this mentality still exists today. A

s a scientist I could go on and on about studies that have shown the importance of parrotfish, but I like to believe that common-sense and traditional practices on these islands do not require such a cold, factious approach.

Therefore I would like to support bill HB 3260, proposing to create bag limits for Parrot fish, Kumu, Munu and Moano Ukali. Currently, these fish can be harvested in unlimited quantities.

Testimony in Support

Dear Chair Ito, Vice-Chair Karamatsu and members:

Thank you for hearing my testimony in support of HB 3260 relating to fishing. I have been a fisherman ever since I was old enough to hold a pole. As a diver, I am now convinced that our reef fish have been depleted to a point that may be unrecoverable. On the island of Maui I am witnessing as much as 90% depletion in most areas. Holes that once held numerous amounts of fish are now virtually empty. The DLNR tells me that it will be 4 or 5 years until bag limits can be implemented through Administrative Rules, that is too long. From witnessing the recent declines we estimate that in 3 years time, the resource will be so depleted there will not be anything left worth regulating.

Commercial fishermen as well as recreational fishermen must abide by the same set of rules. It never should be who you are or what license you hold, taking too much fish is just that, taking too much.

I am not opposed to this law having a sunset clause, as I firmly believe that the public deserves the opportunity to be heard and that is what the Aha Moku Councils propose to do. But until the councils make their recommendation to DLNR as to what bag limit will be proper, and that DLNR adopts an Administrative Rule for bag limits, we must have some kind of protection for our fish in the meantime, or we will simply run out of fish in the five years the process will take. Please pass this bill.

I am a licensed commercial fisherman (#7745), and I fish via trolling, handline, spearfishing, ika-shibi, and bottom fish. I have had this commercial license for over fifteen years now; and have witnessed the changes in our reef fish populations. Keep in mind that we are at sequence 22,000 now if you were to get a commercial fishing license in Hawaii, so over the course of 15 years we have nearly tripled the number of commercial fishing licenses issued. I am also in the business of selling fishing tackle, and see firsthand the many new faces in the commercial fishing industry that have no idea of the status of our resources as compared to even ten short years ago.

In short, we have more commercial fishermen now, and no bag limits pertaining to our resident reef fish that may be near a tipping point of collapse just based on my own personal observations. I am afraid what a truly scientific study would say about the parrotfish and 3 goatfish that

HB3260 is trying to protect from overfishing. As a concerned, responsible fisherman, please hear, support, and pass HB3260 before the damage is irreversible.

The DAR has not done any studies or produced any solid data, or even done a base-line study to prove that these species are in jeopardy. Their facts are strictly anecdotal and these proposed bag limits, as with all bag limits, should be based on well-studied facts and only on facts.

Lastly, I believe that this bill focuses, implies and assumes that if in fact there is a decline of the four species, it is because fishermen. There is a long list of items that may be causing species decline and some of these are:

Aloha ka kou,

My name is Timmy Paulokaleioku Bailey. I was born and raised and currently reside on the island of Maui. I am native Hawaiian and have been a farmer (mahiai) and a fisherman (lawaia) all my life. For the past 17 years, I have been working as a resource manager for the National Park Service. I inherited, at birth, the kuleana (responsibility) to care for our native Hawaiian natural and cultural resources.

The most recent kuleana came to me in October 2007, when Govenor Linda Lingle appointed me as the Aha Kiole representative for the island of Maui, to aid in the development of the Aha Moku Council aystem. It has been a work in progress, and despite not receiving the allocated funding as stated in Act 212, he Council is moving forward.

As the Aha Kiole Advisory Committee representative for the island of Maui I submit this written testimony for HB3260, Relating to Fishing. I have consulted with community members and leaders to submit this coordinated testimony.

The proposed bag limit of listed fish species, with the stated limit of "two per person per day" and the recent amendment of a "two-year sunset" should not negatively affect the the Aha Moku Council system. Furthermore, the "sunset provision" allows the Councils to study, acknowledge, inventory, and present recommendations within the two years of this bag limit law.

It is in the best interest of the Hawaiian people to be involved with these types of administrative rules in order to come up with the best practices and care of all natural resources, whether on land or within the surrounding waters. As the Maui representative, it is not my intent to solely make decisions for the Hawaiian people on any matters that will affect our traditions, values and methods. These matters must be discussed amongst those within their ahupuaa (smaller land divisions) and their moku (larger land divisions).

This bill is specifically for the island of Maui. Thus, the Aha Kiole Advisory Committee is aware of and will be discussing this issue at the upcoming scheduled community meetings on Maui. This bill can be used as an example as a topic that is appropriate for discusion within the

Aha Moku Council system.

Good morning Chair Ito, vice chair Karamatsu and honorable committee members. I am Roy Morioka of Waialae-Iki, Oahu, a retiree and fisherman. Thank you for this opportunity to testify and express my concerns with the measure. While the intent of the proposed bill is to respond to a condition occurring on the island of Maui, I speak not with disrespect to the people of Maui, but in opposition to the bill because it circumvents the current rule making process as provided in Chapter 91 and usurps the authority given the department of land and natural resources (DLNR) who is responsible to assess and manage sustainably our state's natural resources. Additionally, this bill fails to provide current stock assessments of the stated species and sets precedence for future "legislated" fishery management actions without such biological assessments.

I am aware that there can be regionally distinct fishery management measures but there should be included, baseline references, strategies and objectives to determine whether the proposed action is achieving its intended goal, with periodic reviews and status reports to the community. Such actions should also provide a sunset if the objective is achieved allowing changes to either size or bag limits. I also call the attention of this committee to a current project being undertaken by the Hawaii department of aquatic resources (HDAR) to reassess bag limits and size limits of the majority of fish in the State and recommend that selected actions such as provided in this bill to revise bag and size limits be deferred until the HDAR project is completed.
