I have been a faculty member in the School of Social Work for almost 40 years. I am the senior faculty there. I also testify frequently in the legislature about social justice and other issues. I can tell you without ANY hesitation that this is one of the worst ideas I ever have seen introduced in the Legislature. It is a complete scam, and the faculty of the School and the social work community that this bill wants to tax were never even consulted about this reso! Can you imagine? Our own faculty completely undermined by keeping this reso secret!

With professional social workers so poorly paid as it is, how is it possible to even CONSIDER taxing them to pay for a center at the School that is not needed and will just be duplicating the work that we should be doing any way?

The UH School of Social Work SHOULD BE the real "Social Work Center." You probably can see from this terribly destructive reso why we are not.

Please do not support this awful proposal.
