The Department of Human Services (DHS) supports the nomination of Kelsey Kawano to the District Court of the Second Circuit.

Mr. Kawano has worked with DHS on Child Protective Services (CPS) cases on Maui as a parents' attorney and a Guardian Ad Litem (GAL). DHS staff found Mr. Kawano to be professional, fair, and up-front and we welcomed him holding DHS to task. Mr. Kawano is supportive of a family-based approach to child welfare cases including the use of pre-hearing conferences in the Second Circuit Family Court. Pre-hearing conferences were started by Judge Douglas McNish of the Family Court on Maui. They are an effective way to avoid unnecessarily contentious CPS hearings in the Family Court and provide services to the families sooner.

The pre-hearing conference is ordered by the Judge two weeks prior to a CPS hearing.

Those required to attend are the parent/s, their attorneys and the DHS social worker. A Deputy

Attorney General can also be asked to attend if requested by the DHS social worker.

The purpose of the pre-hearing conference is to discuss the services offered to the family and to work out any problems prior to going to Court. The family has the opportunity to consult with their attorney about the services and case plan and changes can be made and agreed upon. Most of the time, the parties come to an agreement and the service plan is agreed to and signed before the Court hearing. Also, by the time of the Court hearing, the family is already engaged in services. This is well received by the Family Court Judge who encourages the family and DHS to work together to resolve the issues that brought the family before the Court. As a result, CPS hearings are more efficient, effective, and less contentious with all parties already in agreement.

The Department is currently working with the First Circuit Family Court to pilot CPS prehearing conferences on Oahu so that families on Oahu can also have the benefits of such prehearing conferences.

We applaud Mr. Kawano for his appreciation and full participation in these effective prehearing conferences for CPS cases. His family based approach and CPS experience would make him a valuable addition to the District Court of the Second Circuit.

In evaluating judicial nominees, the HSBA Board utilizes a modified version of the American Bar Association Guidelines for Reviewing Qualifications of Candidates for State Judicial Office. These Guidelines include the following criteria: integrity, legal knowledge and ability, professional experience, judicial temperament, diligence, financial responsibility, and public service, collegiality and writing ability. The HSBA EXECUTIVE DIRECTOR Board's rating system includes the categories of "highly qualified," "qualified," and "not qualified."

The HSBA Board has recently reviewed the policies and procedures utilized in developing its positions on judicial nominees and has included in its procedures the use of a standing subcommittee of HSBA Board members to review materials presented by the nominee and input from members; the subcommittee is also tasked with checking references and contacting others who have knowledge of the nominee's experience and qualifications. The full Board reviews the materials prepared by this subcommittee, the complete materials submitted by the nominee and members and conducts an interview of the nominee. These revised procedures are available for review on the HSBA website at <HSBA.org>.

Taking into consideration all of the information presented by and about the nominee and an interview with the nominee, the vote of the Board of Directors of the Hawaii State Bar Association found Kelsey T. Kawano to be qualified for the position of Judge, District Court of the Second Circuit.

Honorable Chair and members of the Senate Committee on Judiciary and Labor, I am David L. Coleman. I am the Dean of Humanities and Fine Arts and a Professor of Religious Studies at Chaminade University of Honolulu. I reside at 2813 Manoa Rd., Honolulu, Hawaii.

I am honored to recommend Mr. Kelsey T. Kawano to you for your consideration and confirmation to the District Court of the Second Circuit. I have known Mr. Kawano through our association in the sport of swimming where he has served with me on the Board of Directors and the Board of Review for Hawaiian Swimming. I have also worked with him as Referee for Hawaiian Swimming over the past decade. I have seen his fairness of mind, grasp of complex situations, openness to discussion of conflicting ideas, and his ability to bring the group to a consensus. He is a person high integrity and I know that his work for the county of Maui has earned him high regard among the people of Maui.

Although not a "life or death" circumstance, how one performs as a referee in swimming tells you a lot about the person, their logical abilities, and their moral compass. I have known Mr. Kawano throughout his process of becoming a referee and his activities as a referee and trainer of referees for the island of Maui. He has always demonstrated fairness and applies the rules with an even disposition, looking out for the welfare of the swimmers he serves. Sometimes that means disqualifying the swimmer from an event, but he handles swimmers (and their coaches and parents) with compassion and an attitude of support for their continued development in the sport. He has also demonstrated the same attitude with his fellow officials as he developed an outstanding group of officials for Maui swimming. I have also served with him on the Board of Review, which is the review board for members of Hawaiian Swimming for disciplinary or other decisions made by Hawaiian Swimming. He is knowledgeable of our rules and applies them with great care. Where those rules cross over into civil law, he has been one of our resources as we develop policies and relationships with the wider community.

When it comes to selecting a nominee with a positive judicial temperament, I have found Mr. Kawano to be one who practices "compassion, decisiveness, open-mindedness, sensitivity, courtesy, patience, freedom from bias and commitment to equal justice." Particularly in my work with him on the Board of Review (made up of four lawyers and myself), he has demonstrated a clear grasp of the legal and ethical issues we have adjudicated and the appropriate due process such work requires. The quality of his work earned him selection as the chair of the Board of Review in 2008.

I give my unreserved recommendation to you for Kelsey T. Kawano. He is trustworthy and a person of high character and integrity. While Mr. Kawano may not be as "political" as some nominees, he is devoted to the law. You have in Mr. Kawano a person who has already brought to the bench a fairness that will benefit the community he serves as well as those he must judge.

My name is Lawrence M. Reifurth, and I am testifying in strong support of Kelsey Kawano's nomination to the District Court of the Second Circuit. I have known and worked with Mr. Kawano for several years and offer this testimony in my personal capacity

I have known Kelsey Kawano since at least 2004, when our daughters were both participating in competitive swimming. My daughter swam for a team on Oahu, while Mr. Kawano's daughter swam for a team on Maui. Kelsey, my wife and I were all involved as on-deck officials for Hawai'i Swimming. After a year or so, I also worked with Kelsey as a co-member of Hawai'i Swimming's Board of Review (BOR), a body established in accordance with federal law to hear complaints, protests and appeals regarding the administration and conduct of the sport in Hawai'i.

Whether as deck officials or co-members of the BOR, I worked with Kelsey in roles that involved the application of facts to law or rules, and observed him as he worked collaboratively with others, whether as leader or team member, to ensure fair results to system participants. In each of these roles, Kelsey

demonstrated good judgment, a steady approach to rule enforcement and conflict resolution, and a strong ability to work as part of a team.

As a member of the Hawai'i bar since 1988, I am familiar with and have appeared before many members of the Hawai'i judiciary. I believe that Kelsey has the personality, experience and skills that will make him a fine district court judge, and encourage this committee to favorably consider his nomination.

The purpose of this testimony is to support the confirmation of Judicial Nominee Kelsey T. Kawano to the District Court of the Second Circuit. I have had the opportunity to appear before Nominee Kawano while he was a per diem District Court Judge, and I have also had the opportunity to work with Nominee Kawano while he served as parent's counsel and Guardian ad Litem in the Family Court. Based upon my experience with Nominee Kawano, I have no reservations regarding his confirmation to the District Court of the Second Circuit.

My first interaction with Nominee Kawano was while I was the Supervisor of the District Court Division of the County of Maui's Office of the Prosecuting Attorney. The Deputy Prosecutors that I supervised appeared before Nominee Kawano while he sat as a per diem Judge in the District Court. The feedback that I received from my deputies was that Nominee Kawano was an intelligent and fair Judge, a Judge who evaluated all the relevant information and rendered just and appropriate decisions. On occasion, I would also appear as a Deputy Prosecutor before Nominee Kawano and my experiences mirrored those of my Deputies. Nominee Kawano was intelligent, patient, thorough, calm, and treated the parties that appeared before him with respect and compassion.

After I became a Deputy Attorney General for the State of Hawaii, I began working with Nominee Kawano in a different capacity. No longer was he a Judge that I appeared before; he was now either legal counsel for parents or a Guardian Ad Litem. On some occasions, Nominee Kawano and I would be adverse parties. On other occasions, we would support each other's positions. My observations of Nominee Kawano as a Family Court attorney are that he is a zealous, but fair advocate. He is respectful to both his clients and his opponents, he display's his intelligence and patience in both his work and his demeanor, and he remains full of compassion and concern that justice be done.

Having had the opportunity to work with Judicial Nominee Kelsey T. Kawano in several different capacities, I have no reservations in supporting his confirmation to the District Court of the Second Circuit. I am writing in support of Kelsey Kawano's nomination to serve as a district court judge on Maui. I have known Mr. Kawano for over 20 years, and I believed he would serve the court with distinction.
